#### Introduction

The following information was gathered as a result of Genevieve Hurst's efforts to define the ancestry of my gggraandfather, Ira H Hurst b 1814. She, my sister Phyllis Mc Neeley, wife Pat, and aunt Virgina Weber spent many hours sifting through information at the Libraries and Courthouse. Sherly Behem Petersburg Liberian also graciously provided additional help in the libraries in Petersburg and Rosemarie Stewart helped in the Jasper Court house. Consultation with other Hurst researchers, Douglas Hurst Quebbeman and Eric Hurst was also essential in reviewing the information and providing additional information on the William" Brindle Bill" Hurst family line.

The key documents that support a linkage of Ira to William Hurst are copies of land transactions in Dubois Co during the 1825 to 1836 time frame that have all appearances of an inheritance. Other census records also compliment these records; tax records, marriage records and other information that provides supporting evidence to the conclusions.

In addition to establishing the parents of Ira H Hurst, additional Children of William and Anna and their grand children are identified as well. These connections had not been identified in known literature or Internet listings on this line of the Hurst family As in all research, conclusions based upon a preponderance of evidence are subject to revision as or if more information is forthcoming. At the moment, I am not aware of any additional information or detailed research underway on this line of William Hurst besides which has already been noted.




## **Hurst Family Distribution in 1830**

## William Hurst & Anna (Morgan) Hurst Chronological Summary

- 1765 William Hurst, son of Capt. John Hurst & Lydia Smith was born in Frederick Co VA<sup>1</sup>.
- 1775 William enumerated in Census of Dumore (Shenadoah) Co Va. 1775 as presumed part of family of John Hurst over 16 listed with 4 males under 16 and 3 females
- 1788 Approx. Married Anna Morgan<sup>2</sup> b 1770-1775 d 1830-1840 Dubois<sup>3</sup>

#### Documents & Circumstances Linking Ira H. Hurst to William and Anna Hurst

The following provides information and supporting documentation for establishing an ancestry linking Ira H. Hurst (My GG Grandfather) to William Hurst, b 1765 Va., and his wife Anna (Morgan). William is a son of Capt. John Hurst, b 1732 Va., who is a revolutionary war veteran. Capt. John is the son of William "Brindle Bill" Hurst born in England 1665.

Other land documents and information obtained as part of the same research similarly support a conclusion that Harvey Hurst and Charles Hurst of Bainbridge Township Dubois Co are also children of William and Anna. Land records and tax documents were obtained which also identify the heirs of Charles. This information is provided in another section. In addition there is also a John and Mary Hurst residing in Bainbridge Township who also may be connected to William. These individuals are also covered under a different section.

Background: Ira H. Hurst born on July 12, 1814 is my GG Grandfather who resided most of his life in Southern Indiana with some later period spent in Missouri and a brief time in Ill in the mid 1850's. His death was March 2, 1903<sup>2</sup>, place unknown, but he was last identified in Gibson Co in 1889<sup>3</sup>. Additional details of his life, census information, etc. are in the attachments. . His children and descendants are in the attached family tree. My ancestors are Ira H. Hurst (1), Ira E. Hurst (2), born Dec10, 1856, Ira N. Hurst (3) born Sept 6,1890, and Leslie Hurst (4) born April 20, 1916 and my mother Genevieve (Schmittler) Hurst. Both my parents currently reside in Princeton, Indiana.

William Hurst and Anna (Morgan) Hurst were very early homesteaders in Dubois Co in 1816. William was born abt 1765 in Va. and moved to Green Co TN prior to moving to Williams's parents are Capt. John Hurst and Lydia Smith

Capt. John Hurst was a revolutionary war veteran; He was born approximately 1732 in Va. and died in 1825 in Harrison Co. In. His grave marker placed by the DAR is in Hurst town graveyard north of Cordon.

Capt. John .is the son of William "Brindle Bill" and Judith McCalfee who were original pioneers from England settling in Virginia some where around 1710 to 1732. There have been a number of published sources connecting William Brindle Bill to a Henry Hurst pattern maker b in England who is traceable back to 1460. However this connection is currently under extensive research on both sides of the continent and can not be considered as validated with information currently available.<sup>4</sup>

The family connections between William Hurst, Capt. John Hurst, and William Brindle Hurst are supported by wills and numerous other publications and research on this family line. This family is described in detail in J. C. Hurst's published book "Hurst's of

Shenadoah<sup>5</sup>. B.F. Franklin who corresponded with J.C. Hurst was the original researcher on this line. Ben Franklin Hurst, b 1853 was a grandson of Capt. John. His notes and records have been compiled in an unpublished manuscript titled "Hurst Genealogy" by his daughter Clara Hurst Miles. Currently, information provided by Douglas Hurst Quebbeman, a Hurst researcher, has also proved significant additional information on the Capt John line

## Summary of key documents & circumstances linking Ira H. Hurst to William Hurst:

- 1 Land transactions in 1835 which have the appearance of being an inheritance
- 2 Positive identification of William and Anna as homesteaders in Dubois Co and owners of the land
- 3 Information indicating year of death for William Hurst was in 1835
- 4 Information about Ira's age, place of parents' birth, and census demographics are consistent with information known about William and Anna
- 5 English naming convention used by Ira in naming his children match the family of William and Anna and his in laws Robert Brenton.
- 6 Life time of relationship with neighbors of William Hurst in Bainbridge Township, Dubois Co
- 7 Elimination of all other Hurst's in Dubois and Pike Co as a possible ancestor
- 9 Ira's age when first identified in Dubois were 21. Immigration to Dubois as a single minor would be unlikely

### 3 Split up of William Hurst land in 1835 - 1836

The following information was obtained from the court records of reconstruction conducted by John Hurst after the court house fire in Jasper in 1939. They were obtained in the basement of the courthouse with the help of Rosemarie Stewart.

As an overview, William Hurst owned 320 acres in Bainbridge Co Dubois. Shortly after his believed death in 1835, the land was split up with Ira Hurst, Charles Hurst, and Harvey Hurst each owning 80 acres. Identification of the subsequent owner of the remaining 80 acres has not been established except for 10 acres, which was owned by a Robert and Jemima Miller.

1. Ira H. Hurst sold 80 acres which is the south half of the north east qtr of Sec 22 Township 1 South Range 6W on Nov 23, 1836 to John Hurst for \$ 550.6 This is "the land originally entered by a William Hurst Sept 30, 18167.

### N ½ of NW qtr of Sec 26 of Township 1 S Range 6W

2.. Charles Hurst and his wife Susanna (Lindsey) Hurst sold the north half of the NW qtr of Sec 26 of Township 1 S Range 6W consisting of 80 acres on Dec 3, 1836 to John McCausland for \$275.<sup>8</sup> This was 80 acres of the 160 acres originally entered by a William Hurst on June 26, 1817.<sup>9</sup>

## N ½ of NE qtr of Sec 22 Township 1 R 6W

3. Harvey Hurst and Ann (Davidson) Hurst sold the north half of the north east qtr of Sec 22 Township 1 R 6W consisting of 80 acres on Sept 12, 1848 to William R. Adams for \$400<sup>10</sup>. This was the land entered by William Hurst Sept 30, 1816.. At almost the same time John Hurst sold the south half of 80 acres on Aug 10, 1848 which he had purchased form Ira in 1836 to Ezra Adams for \$400.<sup>11</sup> Harvey and Ann to sell their land had previously given John Hurst power of attorney<sup>12</sup>. Both individuals, John and Harvey, had made an apparent joint decision to simultaneously sell their land.

## S ½ of the NW qtr of Sec 26 Township 1 R 6W

4. The remaining 80 acres the south half of the NW qtr of Sec 26 was apparently split up as 1/8 (10 acres) was owned by Robert Miller and his wife Jemima They sold this land to John McCausland on Aug 27, 1835<sup>13</sup>. Upon close examination of the document, it appears that the last name is probably Miller but may also be Meller. Any other information about this person is not known... It is possible that Robert and Jemima were farm laborers on the William estate as the 1830 census indicates two adults living with William in addition to what is identified as likely children. Or perhaps Jemima is an unidentified granddaughter

Despite a significant amount of effort, the immediate owner or owners of the remaining 70 acres in 1835 after Williams death has not been determined. It has been established that Elijah S. Hobbs was in possession of this ground because it was part of his Last Will and Testament in 1905<sup>14</sup>. There is no record up to 1839 time of the fire in the court house of any one owning this 70 acres prior to Elijah S Hobbs. However, Elijah would not have been old enough in 1835 to have owned the land so there must be another party involved for which the records were destroyed in the fire and were not part of the record reconstruction. This land was passed on in Elijah's will dated Feb 23, 1905. He left funds

for his grandson Edgar A Debruler. Mary Hurst Spradling (believed daughter of William & Anna) married Wesley Debruler. They had a son named Tom who had a son named Edgar A Debruler. Thus Edgar is a grandson of both the Hursts and Hobbs. There may be a connection and possible land transfer in some manner here due to a marriage..

As a side note Elijah Hobbs also bought the John McCausland property at a sheriffs sale on Feb 12, 1860. This land was originally the William Hurst land part of the Mc Causland heirs which included Sara Ann Hurst and Angeline Jane Hurst, children of Ira<sup>15</sup>. John McCausland was Ira Hurst's father in law and had previously purchased the land from Charles Hurst.

## 1 Identification of William Hurst(Bainbridge Twnshp) as son of Capt. John)

#### **Conclusion:**

There was two William Hurst's identified in Dubois Co in 1820. William age 45+ and a younger William age 16-25 called William Jr. in the George Wilson notes and book.. The task is to clearly identify which William owned the land that was split up in 1836. Based upon land deeds I believe this land belonged to William and Anna and not the younger William who is believed to be a son of Sheriff John, son of Capt. John. This would be Williams nephew.

#### **Specifically:**

10ne of the land deeds obtained clearly identifies William and wife Anna selling Section SW qtr of Sec 23 Township 1 S, R 6W to the heirs of John Morgan on Mar 9 1824<sup>16</sup>. The heirs are Benjamin Morgan, Andrew Cotral Morgan, John Joseph Morgan, Evan Newton Morgan, James Morgan, and Charles Morgan. This is the land that a William Hurst purchased on Feb 11, 1817 <sup>17</sup> and this person is the elder William and Anna. A special legislative act was passed which allowed William who was the guardian for the Morgan children to purchase land on their behalf until they became of age<sup>18</sup>

2 The specific owner between the two William's of the remaining two sections of land Section 22 and Section 26 can not be as definitively defined by existing land transactions. The original land records recorded by the state list all transactions as William Hurst. My conclusion is that William and Ann owned both sections of land in 1830. The younger

William (identified as son of Sheriff John of Harrison Co by Douglas Quebbeman) was residing on the Abraham land during 1820. He did not establish a land ownership and returned to Harrison Co by 1826 as reported by Douglas Quebbeman. If he did own a section he sold it to the elder William by 1830. The logic for this conclusion is based upon the land transactions and other circumstantial relationships as subsequently described. George Wilson in his historical notes also concludes that William Jr, Hugh Dyer and Abraham were most likely located in the southern part of the county on the Spencer Co line. The 1820 Census confirms this. William Jr and Hugh Dyer are sequential line entries and Abraham is listed 4 lines later.<sup>19</sup>

3 Both sections 22 and 26 were split into three 80 acre sections and the remaining 80 acres of section 26 appears to have been split in to 1/8 sections. The subsequent owners, Ira, Charles, and Jemima Miller acted virtually simultaneously in disposing of the land(with-in one-year).. Harvey apparently retained the land until 1848 when he and John Hurst both sold simultaneously. We can not positively state when Harvey first owned the land but he is identified in a suit by state of Indiana in 1843<sup>20</sup> as owing taxes on this land. There are also no land transactions listed on this property after 1839 until he sold in 1848. I would presume he obtained it concurrent with Ira and Charles.

Ira had logical reasons for not retaining the land because he was 22 and was getting married to Phoebe Brenton and moved onto or adjacent to the Brenton farm<sup>21</sup> his father in law( 1840 Census into). Charles had previously entered his own piece of land Sec 14 in Township 1 S, R 6W on Mar 5, 1833<sup>22</sup> immediately adjacent to the William Hurst land in section 22 and may not have elected to retain a second piece of land. This land was paid for and a deed issued to Charles on Oct 1, 1835.

The timing and apparent interrelationships of the subsequent land owners interactions would indicate that one person previously owned both sections. If the younger William did own ground initially he may have sold it to the elder William when he returned to Harrison Co.

4 The immediate neighbor to William Hurst is James Payne, William and Ann's son in law. The land William entered in Sept 30 1816 the NW qtr section 22, T 1 S, R 6W was also accompanied on Sept 30,1816 on an immediately adjacent land entry by James Payne<sup>23</sup>, who married William and Ann's daughter Judith Payne in Harrison Co in December 1814.<sup>24</sup>

5 The land entered in Feb 11, 1817, SW qtr of Sec 23 was by William and Anna as identified in the subsequent sale to the Morgan heirs.

6 The land entered in Feb 11, 1817 was also accompanied by an immediately adjacent entry by James Kelly who is likely the James Kelly who fought with William in the battle

of Tippecanoe <sup>25</sup>. James Kelly also served as a laborer for William Hurst. If William (younger) did own a piece of ground it may have been this one with a subsequent sale to William and Ann. This could also account for the land in between these two plots being purchased for the Morgan heirs.

7 The children of the younger William, son of sheriff John seems to be very well documented and does not include a Harvey. There is no apparent reason for Harvey, Ira, or Charles, or Harvey to be receiving or purchasing land some where around 1835 from this younger William. It would be expected that Harvey, who is identified as a son of William and Ann, would end up with land from his parents. Harvey is identified as a son of William by information cited in B. F. Hurst notes<sup>26</sup>

In summary I believe all the above circumstances indicate that William and Anna owned the 160 acres

#### 2 Probable date of death of William Hurst in 1835

Based upon all available information I believe William Hurst died in late 1835.

- Who we believe is William and Ann are listed in the 1810 Census in Harrison Co and their ages are listed as 26 – 45 which is consistent with information know about William and Anna
- William Hurst enters property in Dubois Co in 1816
- The William Hurst and spouse identified in the 1820 Census is age 45+ and 26-44 respectively
- There is a court document deeding property to the guardians the Morgans establishing that both William and Anna are alive in 1825
- The 1830 Census lists William Hurst as age 60-70 and spouse as age 50-60
- The 1830 Survey of Dubois Co lists William Hurst as the owner of the property in Bainbridge Township
- William and Charles donated for the building of the Jasper court house in 1830<sup>27</sup>
- Charles purchased a piece of ground immediately adjacent to the William Hurst property Sec 26 NW Qtr. on Mar 5 1833
- There is a court subpoena to William and the other Capt. John Hurst heirs for appearance to the Oct term 1935 in reference to a estate settlement suite brought by Beverly( a John Hurst descendant form a second marriage)<sup>28</sup>. The court document indicates the subpoenaed parties had returned the summons but did not appear in court
  - Considering travel time the subpoena would have been delivered some time in the spring or summer of 1835. Either William returned the subpoena prior to the start of court sessions or his heirs. An unsuccessful effort was made to retrieve the subpoena from the Harrison Co court house

- Robert and Jemima Meller sold 10 acres part of what was Williams's ground on Aug 27, 1835.
- Charles Hurst and Ira Hurst sold 80 acres each in Oct 1836 of what was Williams property
- There is no listing of a William Hurst in the 1840 Census

. Based upon the subpoena and the split up of William's land in 1836 I would conclude William died some time in mid to late 1835

#### 4 Use of English naming convention by Ira H. Hurst

The English often used a convention for naming their Children. The first son was named for his Grandfather on his father's side. The second son was named for his grandfather on his mother's side. The first daughter was named for her grandmother on her mother's side.<sup>29</sup>. The third son was named for his father. Ira named his children in a manner, which is consistent with this pattern.

Ira's first son was named William Erastus<sup>30</sup>, presumably for his father William. His second son was named Robert Harvey which matches his wifes fathers name of Robert Brenton . His first daughter was named Catherine who matches his wife's mother's name Catherine.. The names of the Brentons were obtained from the "Brenton Family History<sup>31</sup>. It could be a coincidence but Ira H named a subsequent son from another marriage William L . He also named his fourth son Ira Everard who is my line of ancestors.

In summary it appears that Ira was using a convention in naming his Children which supports an assumption that his father would have likely have been named William.

.

### 5 Age and demographic matching

The following shows that what is known about Ira is consistent with census information on the listed ages of children and what is known about William and Anna's origin in Virginia. There is one area of possible conflict in information concerning the birthplace of Ira. There is information that states he was born either in Indiana or Tennessee. The bulk of the information indicates he was born in Tennessee in the 1812 - 1814 time period. William and Anna had migrated to Green Co Tennessee along with Capt. John and his family by 1798. However, it appears they had migrated to Harrison Co Indiana in the 1809

to 1810 time period before homesteading in Dubois in 1816. Thus, either Ira was actually born in Indiana (Indiana Territory) or as a minimum his mother was in Tennessee at the time of his birth. William was in the Yellow Jacket militia during the battle of Tippecanoe during 1812 and their daughter Judith married James Payne Dec 28, 1814 in Harrison Co. There is no way to know if there would be travel back to Tennessee. The George Wilson accounting of pioneer migration indicates several years are involved in the process of migration. Land was worked in the new settlement while residence was maintained in the previous place until the new settlement was sufficient to be self-supporting

### More specifically:

## • Ira's age

Ira's birth date is recorded as July 12, 1814 in the Emma Hurst family bible. She is a granddaughter to Ira H Hurst. This matches with in one year the information provided on the census for 1860.1870 and 1880.

In the 1820 Census there were only 4 Hurst head of households listed in Dubois and Pike Co. These were William age 45+, William age 16-25, Charles age 16-25, and Abraham age 45+. William (Jr.) had one child that matched Ira's age. However, this person is identified as Pinkston by research done by Douglas Quebeman ". William (Sr) and Abraham both had male children matching Ira's age. Charles had no male children that match the age of Ira.

Abraham is believed to be the brother of William and if so, would have had the same birthplace of Virginia with probable residence in Tenn. His land bordered the southern line of Dubois on the Spencer Co. However, Douglas has identified him as the brother of William who left Dubois around 1825. Abraham died in Perry Co, Indiana in 1872. His children also seem to be well researched and identified. . Subsequent and other court records, geographic location of Ira, and apparent relationship with John, Charles, and Harvey centered around the William land. There has been no connection whatsoever identified with Abraham.

Further more both William Jr and Abraham are not present in the 1830 Census. William Jr and Abraham had returned to Harrison Co. Ira was first individually detected in Bainbridge Township in 1833

In addition Charles is a presumed older brother of Ira and Charles is clearly associated with the William in Bainbridge

The 1820 Census lists Charles on the adjacent line entry to William Hurst in Bainbridge

The 1830 Census lists Charles on the adjacent line entry to William Hurst in Bainbridge Township

In summary I would conclude that Charles and Ira were residing on the William Hurst property during the 1820 and 1830 census.

#### • Ira's parents from Virgina

The origins of Ira H Hurst parents as being from Va. is also reported in two newspaper articles. One article is about his son Wesley talking about his parent's heritage and how they came to Indiana from Virginia<sup>32</sup>. The other article is a picture about a large Whig political painting described by Oscar Hurst, grandson of Ira. The article describes the painting as handed down by his ancestors whom Oscar said came from Va. and moved to Dubois early in 1800<sup>33</sup>. Oscar Hurst is a grandson of Ira H Hurst

It has been established by several sources that both William and Anna were born in Va. and were residing in Green Co Tenn. in the early 1800 period.<sup>34</sup>.

### • Ira's birth place

The 1860 census information states that Ira was born in Indiana. The 1870 and 1880 Census says he was born in Tenn. and both his parents were born in Va. Ira E 's death record stated the father as Ira Hurst was born in Tenn. His wife Della reported this. In general the bulk of information indicates he was born in Tennessee. There are two IG indexes with one stating Tennessee and the other Indiana but upon examination these do not appear to have been generated from original information and could have been created from the census information.

Capt. John and members of his family were clearly residing in Tennessee until early 1800. Tax records for Green Co in 1878 and 1879 list a John Hurst, William and Elijah. John and members of his family started migrating through Kentucky and stopping in Bullit Co KY. Elijah first shows up in Harrison Co in 1807. Capt. John, William, Elijah, Abraham, and Jesse Lindsey are listed as voters in Harrison Co in 1809.

William and Anna are likely to have resided in Harrison Co. in Dec 1814 as his daughter Judith Hurst married John Payne in Dec 28, 1814 in Harrison Co. Multiple evidence indicates William had served in the Yellow Jacket battle of Tippecanoe in 1812<sup>35</sup>. There is also a William being subject to taxes in Harrison Co in 1813<sup>36</sup>. Whether or not this is the older William or his nephew can not be distinguished except the older William is more likely to have taxable property. Exactly when Anna and the William's family may have moved to Harrison Co or Dubois is not clearly defined. There is an 1810 Census for a William Hurst in Harrison Co. This census is consistent with what is known about the probable ages and the known children of William and Anna. William had a land patent issued in 1816 in Dubois Co.

Ira's age and gender is consistent with the William Hurst 1810, 1820, and 1830 census information and what is known about William and the other siblings guardianships (Attached comparison). Ira's birthplace, if in Tennessee and not Indiana, would be at odds with a logical conclusion that William most likely moved directly from Harrison to Dubois. As stated in several publications a move by a family may take several years.. It is also possible that William or Anna may have been in Tennessee for some reason before moving

to Dubois Co Indiana. As a minimum Anna may have returned or been there during the battle of Tippecanoe

At any rate there has not been evidence that actually ties what is believed about Ira's state of birth together simultaneously with the known location of Anna

## 6 Ira's proximity and relationship to residents of Irish Settlement centered around the William Hurst Homestead

William Hurst was one of the very first land entries into Dubois Co. on the Pike Co. border in 1816 and he settled in an area close to what was called the Irish settlement and know today as Ireland Indiana. His land was in the center of the settlement and upon examination many of his neighbors either were directly related or had close relationships to William.

The people Ira H. Hurst, Harvey, and Charles functioned with and interacted with were also in this same immediate area of not greater than two square miles. An attached early Platt map shows these people and is marked as to the relationships or interactions.

• After the end of 1820 there were no more land purchases in this part of Dubois Co. until 1833. The 1820 Census listed Abraham, William SR, William Jr., and Charles as the only head of household in Pike or Dubois.

Only William Hurst and Abraham were landholders. Thus Charles, a head of household, and presumably Ira and Harvey as children were residing on either William's or Abraham's land. There have been no circumstances whatsoever found which would connect Ira, Harvey or Charles to Abraham

#### The following is a listing of these transactions or relationships:

- Charles and William jointly donated to help build the Jasper court house in 1830
- Land entry's were made on Mar 5,1833 by Charles with 40 acres SW 1/4 SW 1/4 Sect 14, T 1 S, R 6W which is immediately adjacent to the William Hurst land<sup>37</sup>. Williams neighbor James Payne purchased adjacent land the same day as William Sept 30,1816.<sup>38</sup> This is William's son in law having married Judith in 1814<sup>39</sup>.

Jesse Lindsay homesteads close to the William Hurst land and he is the husband of Leah, William's sister.<sup>40</sup>

- A John Payne also homesteaded next to William buying land in Feb 4, 1817 Abraham purchased land May 18, 1817 <sup>41</sup> on the southern boarder of Dubois Co. Abraham is a brother of William Hurst<sup>42</sup>
- Other early 1817 neighbors to William were Andrew Anderson. By 1835 the families Ira had relationships with were also located in the same area as the William land. Zack Mc Allister, Wesley Debruler, and John McCausland (Ira's father in law)
- David Anderson son of the Andrew Anderson, neighbor to William Hurst, also became the guardian of two of Ira's children<sup>43</sup>. David's wife was Elizabeth (McCausland) who was Ira's sister in law<sup>44</sup>
- Harvey and Ann sold land on Aug 25, 1848 to Andrew Anderson that was adjacent to the William Hurst land. This was the SE ½ of the SE ¼ of Sect 27, Township 1 S, R6 W. This land was originally owned by Merritt McAllister and was part of a Davidson inheritance.<sup>45</sup>
- Ira purchased 15 acres in Bainbridge Township on Oct 28, 1857 in SE ¼ SW ¼ of Sect 13, Township 1 S, R 6W which was owned by Richard & Mary Postlewait. 46 Ira sold on Feb 6, 1857 this same parcel which included the current Madison township where the William Hurst land was located.
- Ira was first married and lived in Pike Co in 1840 and again in 1860. The William Hurst settlement is on the Pike Co border.
- Ira's two children Robert Harvey and Wesley Sylvanus were bound to Carter Runnel and Mary who may have been a Mc Allister in Bainbridge township after the death of Ira's first wife Phoebe Ann<sup>47</sup>
- Wesley Sylvanus, Ira's son, enlisted into the Civil war from this Bainbridge township.
- , Ira's daughters inherited a piece of the original William property via an inheritance from John McCauslnd (Ira's second father in law) 48
- Spencer L (Logan) Hurst son of Charles was in Newton Township III, just south of Mattoon III in 1853 .His son William Payton Hurst was born there Dec 8, 1851<sup>49</sup> . Ira

H Hurst son Ira Everad Hurst was born in Mattoon Ill Dec 10, 1856<sup>50</sup>. This location could be a coincidence or perhaps not on the basis that Spencer would be a nephew of Ira.

David Anderson guardian of two of Ira's children moved to Lykins Co (Miami)
Kansas with Ira's children just outside of Kansas City in 1848<sup>51</sup>. This is also the same
time Harvey sold all his land and moved to Lee Co. Iowa <sup>52</sup> Ira spent a number of his
later years in Mo. in Clay Co. just north of Kansas city, perhaps because of some of his
relationship and children were there.

The Dubois historical books provide an accounting that by the end of 1840 large numbers of German settlers were arriving in Dubois Co establishing permanent homesteads and the more pioneering individuals in the Irish settlement had predominately moved further west in to Mo. and Arkansas

In Summary a lot of Ira's as well as Harvey's and Charles interactions were with individuals in this settlement which would be typical of a native of that community with a number of relatives in the area

#### 7 Previous lists of children of William and Anna.

Known list of children of William and Anna identify Harvey but do not specifically list Ira or Charles .

I believe the list of children for William and Ann Morgan all originated with the unpublished notes and letters researched by Benjamin Franklin Hurst born 1853, Indiana and died 1936. He was son of John (Sheriff Harrison and son of Capt. John Hurst) His work was compiled by his daughter Clara Hurst Miles and called "Hurst Genealogy". (Unpublished). I believe this is the most comprehensive research of the William Brindle family line in existence pending the additions and corrections of work underway by Douglas Quebbeman and others. I have seen some variations to this original list as follows

Accounting of Children of Williams as listed in Clara Miles notes title "Hurst Family" page 43:

: "William Hurst ( son of John and Lydia Smith Hurst) m Ann 'Morgan (dau of William and Elizabeth Hurst Morgan) William and Ann had 10 children. Do not have any information on these children except, Mary Hurst, who married Hugh Dyer in 1818 – This

information is listed under the descendents of Mary Hurst Dyer and Charles Dyer. The names of the children of Elizabeth and Ann are John Ezekial,- Sarah- David - James - Mary(married Hugh Dyer) Julia-Harvey-Judith. It goes on to say "this is all we know about the children". I assume Clara meant to say William and Ann instead of Elizabeth. He also lists only 9 by name.

#### Recent (Oct99) addition to June Reed Web Page on Hursts

A recent addition to Junes Web page added William Washington Hurst as a son and added a middle name of Robert to William making it William Robert. I have been in contact with to other researches of the William Washington Hurst from North Carolina, David L. Hurst and Claudia Reeves and they have no knowledge of the connection. I also have copies of hand written letters dated Sept 11, and Sept 20,1900 form Adelphus Augusta Hurst (ggrandson of William Washington Hurst) to B. F. Hurst concerning William Washington Hurst's father. The name had been forgotten by Adelphu's father who was still living but he did list 4 brothers to William Washington as George, Thomas, William, and John. The additional list of Children is not consistent with what is known about William and Anna. The next step is to contact June Reed and ask for the source of the submitter of the information. There are also what appear to be arbitrary birth dates assigned in order of the Clara Miles list in 2-year increments. Most of these dates are inconsistent with marriage information or census information on William.

Out of the above list we know:

- Harvey Hurst is listed as a child and he in fact appears to have inherited part of the William Estate which would be expected.
- There is a Judith Hurst who did marry John Payne in Harrison Co in 1814 and they located next to William Hurst settlement in Bainbridge Township. The index of marriages by Walter Beanblossom identifies her has the daughter of William
- There is a Jane Hurst who married Hugh Dyer in Harrison Co in 1818. The unpublished manuscript by Clara Miles identifies this person as possibly Mary of William and Anna. I have some questions about the validity of this connection and they are covered in another section on John and Mary Hurst of Dubois
- There is a John Hurst and his sister Mary Hurst who are active residents of Bainbridge Township from 1833 to 1850. Factors which may or may not identify them as the John and Mary of William and Anna are listed in the section of John and Mary Hurst of Dubois
- Charles Hurst is not listed as a child of William and Ann. However, in addition to the apparent land inheritance there is a lot of evidence (Section on Charles) which would say he is a son of William. It is very possible that the Daniel or David Hurst may have been a Charles David or Charles Daniel and the family used the middle name. The same condition existed with Spencer Logan as his family knew him as Logan and only recently equated him with the Spencer L in Dubois Co<sup>54</sup>.. Spencer is identified as a child of Charles in the Charles Section
- Ira Hurst is not listed as a child of William and Anna. However, the list does not appear to be well defined and researched with supporting documentation except for the original listing of names that listed 9 instead of 10. Where the name Roger came from is not known or was this a nickname for Ira. Roger is not a normal Hurst name in any family line. The list also may not have been complete. Ira would have been an infant at the time William located in Dubois and the list may not have identified young infants remotely located form the bulk of the family in Harrison Co..

Another remote possibility is that Julia may actually have been Ira. During the 1800's I's were often written as a J, particularly by the Germans, and in that case a Jra is difficult to interpret. As a result Ira is identified in the 1840 Census index as Jired and the microfilm transcription lists him as Fred<sup>55</sup>. The tombstone of his wife Francis identifies her as the wife of J. Hurst<sup>56</sup>.

• There is no hint with in Indiana of any Roger Ezekial, James, Sara, Julia, or Daniel or David being detected in any manner. Any identification or indication of these people in the form of birth date and marriages has not been made. Other names besides Harvey, Charles, Ira, and John do not show up during the time Williams the Children would have been getting married, purchasing land, appearing in Census, etc. It is highly possible that Roger may have been Ira and David was Charles or "Charles David" and the others may have died young with no trace. The death rate in Dubois in

the 1820's was extremely high. The girls could have also married young and with the Court house burning in Dubois there would be no record.

I have put together a reconstruction of the Census information on William and Anna from 1810 to 1830 and tried to match based upon probable age and gender to the known names and children of William and Anna. The chronological sequence would indicate that 2 of the William male children died between 1810 and 1820. It would also indicate that 2 of the girls died between 1810 and 1820. This type of comparison requires some guess as to probable name assignments and can only be considered as a guide to a possible scenario

#### 8 Ira is first identified in Dubois at age of 22

I believe there are two conditions in defining the ancestry of Ira H Hurst, Either he came into the Pike Dubois area as a single unmarried individual under the age of 22 or he was part of one of the established families in the area. The likely hood of a single young person moving individually into what at that time was a virtual wilderness is highly remote. There are no other Hurst's that were not already in Dubois detected during this period of time. The George Wilson history of Dubois Co states that migration had basically stopped into Dubois after the mid 1820's until around 1837 when the German settlers started arriving. A rather large oil painting of Henry Clay that was handed down by Ira obviously was preserved as part of a family possession. A 21-year-old single male by himself would not have been likely to have kept and moved such a possession.

No other families besides those already noted have been identified moving into the Dubois-Pike area prior to the time in which Ira was positively identified in Dubois Co via the 1833 land transaction. Thus he most likely has family ties to the Hurst families already established.

# <u>9 Elimination of other Hurst's besides William and Anna in Dubois & Pike as</u> potential ancestors to Ira

Attached is a matrix showing all the <u>adult</u> Hurst's in Pike and Dubois Co between 1800 and 1860 which I have been able to detect through census, marriage records or other family trees.

Assuming that Ira migrated to Dubois as part of a family group and not an individual minor child there are only three possible candidates out of this entire group which could possibly qualify as a parent on the basis of age or country of birth..

- 1. One is the William and Anna Hurst described previously. There are circumstantial and land document ties which support a likely connection.
- 2. The second is Abraham Hurst brother to William Hurst.. He has been rejected as a likely candidate on the basis that he left Dubois early in 1820's, his children have been identified, and there has not been any circumstances detected which would tie to Abraham.
- 3 The other is a William Henry Hurst.

- William Henry Hurst first entered land in Aug 1836 in Bainbridge Township, which is close to the William Hurst property. He was issued a land patent Feb 1, 1839<sup>58</sup>. The Debrulers also located adjacent to William Henry Hurst. Westly Debruler married Mary (Hurst) Spradling<sup>59</sup> who is John Hurst's sister<sup>60</sup>, Their son L.Q. Debruler also married Johns sister in law Huldah Angeline Condit (Condict) (of James H.), March 7,
- Based upon time lines and identical death dates, this William Henry Hurst is likely to be the William Henry Harrison Hurst born abt 1817 who is son of Beverly(son of Capt John by second marriage). Beverly and his family resided in Spencer Co 1830 to 1860 Refer to section on William Henry Hurst & Albert & Jessie Hurst for details and logic
- William Henry Hurst has also been rejected as a likely candidate for as a parent of Ira because he is identified as having heirs<sup>61</sup> and they appear to be Jessie and Albert who appear to have inherited his land.<sup>62</sup>

In summary: There is nothing detected that indicates a connection of Ira to William Henry Hurst.

All remaining identified Hurst individuals in Dubois and Pike can be accounted for. The German Hurst families started appearing in 1940 and are primarily identified as German descent on information obtained from Wilson's historical notes.

Refer to the attached chart which summarizes the timing and interrelationships of all Hursts detected in Dibois and Pike Co from 1810 to 1860. Additional specifics of individuals where known are included in the attachments and other sections defining suspected relationships.

#### 10 Summary and conclusion

In summary I believe it probable that Ira, Harvey, Charles, each acquired \( \frac{1}{4} \) of the William Hurst estate after his death as an inheritance. The alternate scenario is that the Hurst's actually purchased the land either directly from William or through unidentified individuals who may have purchased the land from William while he was alive and then resold it to the Hurst individuals. I believe the alternate scenario is less probable than the

first due to a short time span after Williams death and the lack of an obvious reason for some one to buy land and sell it to 3 non related Hurst 2 of whom immediately resold.

. Ira sold his land at the age of 22 to John Hurst. (John Hurst may be a brother as discussed in the section on John Hurst) With in 1 week, Charles also sold his land. Harvey and John sold the land several years later with in one week of each other. Another individual possibly a niece or unknown granddaughter of William sold 1/8 of the remaining 1/4 during the same period of time.

If Ira had not inherited the land from William it means he would have purchased it at an age younger than 22 which could not legally be more than one-year prior.. It would not be logical for him to have bought land with the intention of an immediate resale . The financial means for a young person at that time to purchase land would be unlikely. In fact after selling the land, Ira married Phoebe Brenton and resided on property owned by her father Robert Brenton. It is difficult to conceive of any circumstance that would prompt 3 non related Hurst individuals, Ira, Harvey, and Charles to simultaneously decide to purchase ¼ of another Hurst land and then resell at the same time unless they were related and disposing of land they had inherited.

#### **In Conclusion:**

The evidence of actual land deeds which match what appears to be a land inheritance from William Hurst plus the large number of incidental connections to the William Hurst family and community leads to a reasonable conclusion that William Hurst in all probability is the father of Ira, Charles and Harvey. Obtaining further direct proof such as a will is highly unlikely due to a fire in the Dubois Co Court House in 1939 that destroyed all court records.

Circumstances also make it likely that John Hurst and Mary Hurst who resided in Bainbridge Township are also the John and Mary identified by B. F. Hurst in the list of children of William and Anna. ( Refer to sections on Charles, Harvey, John & Mary)

#### **Opportunities for further research**

John Hurst (JP of Dubois Co) b 1803 Tenn. has been traced to Washington DC where he died in 1866 per the Peter Condicit family History. Determination of his exact death date might lead to an obituary in the Washington paper, which could shed light on Johns surviving relatives and ancestry. A search was made of the Index and Register of Interms for Washington DC was made for 1855-1857 and a John Hurst could not be located. Perhaps he died in New Jersey where his daughter was. A search was also made at the National Archives and there is no will for a John Hurst in Washington DC. John had another daughter in Spencer Co Ind and had appointed L.Q. Debruler as power of attorney. Perhaps there is a will in Spencer Co.

There is supposedly an index of permission slips created by the Southern Indiana Historical society for the Corydon Court House residing in the New Albany Library. It was done by Walter Beanblossom Obtaining a copy of the permission slip index might provide more information on who signed for Jane Hurst who married Hugh Dyer (reported to be Mary Jane by Clara Miles) and Judith Hurst who married James Payne.

A request was made to the Albany Library for a copy of the index. No index of marriages by Beanblossom was listed for Judith or Jane Hurst.

- An alternate list was obtained. It did not include the Jane and Hugh Dyer marriage but did identify Judith as a daughter of William. An extremely remote possibility is that a permission slip, if one was made, still resides in Harrison Co Courthouse
- Harvey Hurst moved to Lee Co Iowa in 1848 and there is a Harvey Hurst listed in the adjacent county (VanBuren) in an 1852 census. Obtaining the specifics of the census may lead to further tracing of Harvey.
- There is a newspaper comment on Ira H. Hurst in the Jasper Weekly Herald dated April 3,1859. The microfilm version of this paper in the Jasper Library was damaged for that date. Finding the original paper or an alternate microfilm might provide some pertinent information.
- Burial location for Ira H. Hurst
  - The death date of Ira Mar 21, 1903 is known, but the burial place of Ira H is not known. The logical place is Gibson or Vanderburg but a through search of the records in So Indiana did not locate a record of either Ira or his wife's death. She died on Mar 27, 1902 <sup>65</sup> The Owensville newspaper, which might have contained an obituary, is missing from the Owensville Library. A search out side of Indiana for a 1900 Census on Ira H including Missouri needs to be made as well...

### **Documents Linking Charles Hurst to William and Ann Hurst.**

The same basic evidence that supports a linkage between Ira H. Hurst and William and Anna Hurst also applies for Charles. His residence appearing to be on the William Hurst settlement further strengthens the evidence for Charles.

Charles Hurst was identified as an original head of household in Dubois Co in 1820 Indiana Census. He married a Susanna Lindsey in 1818 in Pike Co<sup>2</sup>. There was a history of inter marriages with the Lindsey family with in the Capt. John Hurst family. William's sister, Leah, married Jessie Lindsey who located in Township 1 (Bainbridge) on Aug 29, 1820.

#### **Charles Hurst Chronological summary of known information**

- **1795 Born** between 1790 and 1800 based upon 1820 and 1830 Census
- 1818 Married Susanna Lindsey in Pike Co Dec 24, 1818
- **1820** Listed in In Dubois Bainbridge Township Census. A few line entries away from William Hurst with other relatives of William.
  - With one female 16-25 (presumably Susanna) and 1 female under 10
- 1830 Listed in 1830 Dubois In Census immediately adjacent to William Hurst
- 1830 Charles and William Hurst helped fund the new courthouse in Jasper<sup>3</sup>

Also as previously stated, Charles was most likely living on the William Hurst homestead until 1833 when he purchased from Indiana a plot of ground diagonally adjacent to the

William Hurst land. This purchase was made on Mar 5,1833 by Charles with 40 acres SW 1/4 SW 1/4 Sect 14, T 1 S, R 6W.

Why Charles was not specifically listed as a child of William in the B.F Franklin notes is not known. Charles was clearly detectable in the 1820 census. He is listed a few lines from William in the 1820 Census and immediately adjacent to William in the 1830 Census. Wilson's Historical notes also provides an accounting of Charles and William contributing to building a public building in Jasper in 1830. As previously stated, the list of William's children may be incomplete or was known by the family by a middle name such as David.

Census information for Charles and Susanna and their Children is as follows. The children appeared to inherit the Charles Hurst land. Specific details follow. Spencer Logan Hurst is traceable to descendants living today.<sup>9</sup>

#### **Charles Hurst**

Charles Hurst is listed as an original head of household age 16-25 with one girl in Dubois in 1820 along with William (SR) the other William, and Abraham. He is also identified as marrying Susanna Lindsey in Pike Co on Dec 24, 1818. Charles purchased the SW1/4 SW ½ of Sec 14, T 1 S, and R 6W from the in government in Mar 5, 1833. This land was diagonally adjacent to the William Hurst property. He is believed to be a son of William and Anna based upon land documents which appear to be an inheritance, census information, and numerous circumstances.

## Key documents and circumstances for establishing Spencer, James, and Jane Ann (Hurst) Blacks as heirs of Charles:

### • Land Documents that appear to be an inheritance

1 Charles Hurst heirs are listed in the 1847 delinquent taxes list for Bainbridge Township as owing taxes. The specific names were not listed and they were only identified as heirs to Charles Hurst<sup>12</sup>

2 Spencer Hurst, William Black and wife Jane, and James and Mary Ann Hurst are listed in the record of deeds book 3/382, date Sept 23, 1847 as selling SW of the SW qtr of Section 14, Township 1 S, Range 6 W consisting of 40 acres to Amos Hurst. 3 Amos W. Hurst and wife Catharine Hurst sold the SW qtr of the SW qtr of Section 14, township 1 S, Range 6 W consisting of 40 acres to Robert Blair for \$200 on Sept 30, 1848.. I assume that Amos consolidated the property among the hiers and then sold the property. 4 Charles heirs are not listed in 1848 as owing delinquent tax list.

#### • Census information in 1820 - 1840 matches perfectly with the heirs.

A matrix was put together using the information in the census for the years 1820 1830, and 1840 all in Dubois Co, Bainbridge Township. Everything matches perfectly with what is know about Charles, Susanna and the presumed children James. Spencer, Jane Ann, and Amos W.. In the 1840 census Susanna is listed as head of household, Charles is not present, and she is listed immediately adjacent to William Black who married Jane Ann on Dec 13, 1840. Charles presumably died some time between 1837 after he sold the William Hurst land and 1840. Susanna is not listed in the 1850 census and considering the land was split up in 1847 she presumably died some time between 1840 and 1846. This matrix is attached.

### **Spencer Logan Hurst**

His descendant Mildred Spaw who is still residing in Oakland City, In (Pike Co) has identified Spencer L as Spencer Logan. He was actually known as Logan to the family. Spencer L married Lavinia Black in Pike Co in 1848. Logan gave birth to William Payton Hurst in a small town south of Mattoon Ill in 1853. Ira E. Hurst, son of Ira H was born in Mattoon Ill in 1856 This location could be coincidence or the result of a relationship between Ira and Spencer of Uncle and nephew.

There is a good possibility that Spencer was named after Capt. Spier Spencer of the Yellow Jackets militia.

Mildred Spaw has compiled a complete family tree and line of descendants of Spencer. Spencer's first two children were named William and Charles who matches his suspected ancestry. William Payton also named his son Charles and his grandson was also named Charles. Initial portion of Spencer Logan Family Tree

- 1848 Spencer married Lavinia Black Sept 27, 1848 in Pike Co. Children:
  - Mary Elizabeth Hurst b October 27, 1849 –
  - William Payton Hurst b September 8, 1851 near Mattoon Ill. Died December 24, 1932 in Pike Co, Glezen Indiana. Married Hanna Traylor
    - 8 children with several lines continuing into Pike and Gibson Co In including Maude Essia Hurst b May 25, 1885 and died 1970 and daughter Mildred Hurst Spaw
  - Charles Alexander Hurst b May 19, 1854 Married Eliza Meyers
    - 3 children including Charles Prentice Hurst b Jan 29, 1897 and died Feb 17, 1944 in Pike Co.

#### **Amos W Hurst**

Amos W. Hurst married Catharine Orfield in Pike CO on July 7, 1845.<sup>4</sup> He sold the land originally owned by Charles Hurst land in 1848. This is the last specific information known. This is the same year as Harvey sold his land. .

An Amos Hurst is listed in the Mo. Census in 1850 in Andrew Co. (North of Kansas City) A comparison of the census details to see if the ages, birth place, etc. match the Amos from Dubois needs to be done as further research

#### Jane Ann Hurst

Jane Ann Hurst married William S Black in Dubois Co Feb 13, 1840<sup>5</sup>. Jointly owned and sold land inherited from Charles. No other information is known

#### James Hurst

No other information is known about this James than what is listed in the index of deeds. He does not appear in the Census or marriage records. He probably moved after the land sale along with Spencer and all the other Hursts and would not show up in the 1850 Indiana census.

There is a James W. Hurst listed in the Pike Co 1860 census the right age and state of birth. There is nothing else that establishes that these two people are the same individual. Information on the James W. Hurst follows.

#### James W. Hurst

The relationship if any of this James to the James who shared the Charles Hurst land is not established. James W Hurst is residing in Pike Co per the 1860 census. He is identified as farmers age 38 (Born 1822 in Ind.). A wife named Catharine age 30 from Ky. They have 7 children listed James F 14, Cloe 12, Marilda, 10, Lavinna 8, Sarah 6, Susan 4, Mahala 2. All the children except the first were girls. No other information is known and he is not present in the 1850 Pike Census. Squire Hurst is also in the same Co in the 1860 census. There is a possibility they might be from the Fleming Co Hurts but this is pure speculation.

# **Harvey Hurst**

# **Evidence Linking Harvey Hurst to William and Anna Hurst.**

The same basic evidence that supports a linkage between Ira H. Hurst and William and Ann Hurst also applies for Harvey Hurst. There is an even stronger case here because Harvey is already identified as a son of William and Ann¹ and the additional land transactions and relationships to the William Hurst settlement only further supports what was already stated. The first time Harvey is identified with the land is a law suite of the State of In Vs Harvey and Ann Hurst for taxes in Feb 21,1843.² The land was ordered for sheriff's sale unless taxes were paid. There are several court documents related to these taxes.

Harvey was married to Ann Davidson on Mar 31, 1842 in Dubois Co per the Indiana searchable marriage records. However based upon copies of the land deeds and power of attorney, I believe Ann Davidson may be a Davisson<sup>3</sup>. The court documents are quite legible and with in two different documents prepared at different times the name Davisson is used consistently. Davisson is also a family name in Dubois as well as Daividson.

# Chronological Summary of known information about Harvey

- 1842 Married Ann Davidson Mar 31, 1842 in Dubois Co
- **1843** Law suite in Feb 21, 1843, State of In Vs Harvey and Ann Hurst for taxes owed on land that had previously been William Hurst land.
- **1843 Harvey**, Andrew Anderson & Moses Kelso were Trustees of the Shiloh meeting house who petitioned Zack McAlister to sell 1½ acres of ground (previously part of the John Mc Causland estate) that was the local burial ground next to the original Shiloh church<sup>4</sup>. This cemetery became Hobbs's and eventually the Hillsboro Cemetery... The gravesite is filled with the Anderson's including the revolutionary war veteran, the Morgan children, the Mc Causlands, Ezra Adams, and many other neighbors of William and Ann. The only Hurst in the site is Francis Jane (McCausland) Hurst, second wife of Ira
- **1848** ( **or before**) Moved to Lee Co , Iowa<sup>5</sup>
- 1848 May 12 Gave power of attorney to John Hurst <sup>6</sup>
- **1848 May 13** Sold 80 acres of land (via John Hurst) to William Adams (part of the original William Hurst homestead)<sup>7</sup>
- 1848 May 13 Gave power of attorney to B.F.Davisson to sell land<sup>8</sup>
- **1848 Aug 28** Sold land to Andrew Anderson ( Part Ann Davisson Hurst <sup>9</sup>inheritance)

- **1852** There is a Harvey Hurst listed in an 1852 Iowa Census in VanBuren Co (neighboring county to Lee Co, Iowa)<sup>10</sup>
- In 1848 Harvey began selling all of his land.

By the 13 th of May, 1848 Harvey and Ann had moved to Lee County in Iowa. This is on the Ill and Mo. borders. They had given power of attorney to B. F. Davisson on May 13, 1848. He and Ann sold to Andrew Anderson on Aug 28, 1848 SE ½ SW ¼ Section 27, Township 1 S, R 6W which was part of the Davisson inheritance. This land was owned jointly by Benjamin Davisson, William Davisson, Sarah Davisson, and Ann Hurst. This land was originally owned by Merritt McAlister and purchased from the state April 4, 1837.

Harvey and Ann also gave power of attorney to John Hurst to sell their land on May 12, 1848. Harvey Hurst and Ann) Hurst sold the north half of the north east qtr of Sec 22 Township 1 R 6W consisting of 80 acres on Sept 12, 1848 to William R. Adams for \$400. This was the land originally purchased by William Hurst Sept 30, 1816. At the same time John Hurst sold the south half of the north east qtr of Sec 22 Township1, R 6 W to Ezra Adams for \$400. This was also part of the land originally purchased by William Hurst

Little more is currently known about Harvey.

There is a Harvey Hurst listed in Iowa VAN BUREN CO. LICK CREEK TWP. The copy of this census has not been obtained. It may provide further information

Two children were located in Miami Co Kansas Ospwatomic Township in the 1870 census that may be children of Harvey. They were born in Iowa at the same time Harvey would have been there and the other people in the Ospwatomic Township are the Anderson's with whom Harvey and the Hurst family had relationships. David and Elizabeth (Mc Causland) were the guardians of Ira's children Angeline and Sara and moved to Miami Kansas with the children.

# John Hurst (Dubois JP) & Sister Mary( Hurst)( Spradling )Debruler

Based upon transactions with members of the William Hurst family and neighbors I believe it is probable that John Hurst and his sister Mary who married a Spradling are the listed children of William and Anna. However, there is information that is reported in the Clara Miles work that states it is believed Williams's daughter Mary may have married her cousin Hugh Dyer. If this is correct, then John and Mary are from another family. However, there are circumstantial conditions and information that make me believe that it was Jane, the daughter of Abraham (William's brother), who married Hugh Dyer and not Mary daughter of William and Anna. Hugh Dyer would have been a cousin in either scenario

# What we know about John Hurst and Mary Hurst is:

John Hurst is the subject of a 5-page biography by George R. Wilson. "Biographical Sketch of John Hurst, A Prominent Pioneer of Jasper" which is part of his unpublished notes on the history of Dubois Co. George as a young adult personally knew John's sister Mary but lamented that he had little interest in historical matters at that time and failed to learn about John's origins. The following is a combination of information obtained from that biography plus courts records and land deeds found in Jasper, Dubois census, and the "Condicit Family History"

#### **John Hurst**

- 1803 The 1850 Indiana Census states his age as 47 and born in Tennessee
- **1832** He first is detected in Bainbridge with Jacob Enlow on Dec 13, 1832 jointly buying a parcel of ground in Bainbridge Township northeast of Jasper<sup>1</sup>. Jacob Enlow is listed in the 1830 Census 2 lines away from William and Charles Hurst. He is suspected to be a son of Henry Enlow also listed who served with William at the battle of Tippecanoe. John was not listed in the 1830 Dubois Census as head of household. Unless he just showed up mysteriously between 1830 and 1832, which is unlikely, he must have been living some place but not as a head of household in 1830. The only two Hurst homesteads at that time were the William Hurst family or the Abraham Hurst settlement that I believe had already been abandoned at that time. John's age is consistent with the Census information in 1830 for the William Hurst household.
- **1836** He bought 80 acres from Ira H. Hurst in 1836 that had been part of the William Hurst estate and maintained the land with Harvey Hurst until 1848<sup>2</sup>
  - A previous argument I made was that John the JP could not be established as a son of William was that there was no evidence of him receiving a share of the land except by buying. A counter to that is that the remaining 70 acres of Williams's land has not been identified as to who obtained it. It could be John and he was simply buying Ira's share. At any rate it has not been established that John received a share of the land but it has also not been disproved.

- **1836** John Hurst married an Amelia Theodosius Condicit in Warrick Co on Oct 27, 1836. Warrick Co is south west of Dubois Co.<sup>3</sup>
- **1836** John first became Justice of Peach as well as in 1841 and 1847<sup>4</sup>
- **1836** John built a store in Jasper on 5<sup>th</sup> and main street
- **1839** John Hurst continues to be active in buying land in Dubois in 1839
- **1839** John Hurst was operating a store in Jasper. His father in law James H Condict was also operating a hotel. It was robbed in 1839
- **1839**John Hurst was the key individual who conducted the record of testimony that recreated some of the destroyed documents after the Court house fire in 1839, He was also an active politician and Whig
- **1839** Mary Hurst Spradling, John's sister married Wesley Debruler in Dubois in 1839. Mary was a widow. They lived on the old Jasper Petersburg Rd near the Pike co line<sup>5</sup>. Date of Mary's prior marriage to Spradling was not found and presumably lost in the 1839 fire.
  - John Hurst had a niece Sophia Spradling born 1833 who married James Porter Downey. Date not known. James Downey was the son of Alex R. Downey the minister in the Irish settlement. In 1839 he entered 40 acres adjoining and immediately west of the William Hurst land. His son James later entered into 40 acres west and adjacent to Alex. In general it appears that by 1839 all the John Hurst family, his sister Mary and niece, William Henry Hurst, the Debrulers, and the Downey's lived adjacent or within a couple of miles to the original William Hurst homestead.
- **1840** In the 1840 Dubois Census John Hurst is listed as age 30-40 and has a single male child age between 10-15 living with him. No female. His entry on the census is adjacent t to LQ Debruler who is the son of Wesley Debruler, I also thought it is of interest that 3 lines down from John is a Condicit. Who the 10-15 year old male child is a mystery. Why Amelia Condicit did not t show up on the census is also a mystery.
- 1840 John Hurst was a member of the board of county commissioners
- 1840 1848 John Hurst was an active Whig and was a member of committee on resolutions at Whig convention. On Jan 6<sup>6</sup>
  - Through out 1840 to 1850 John Hurst continued to be very active in politics, and running his store in Jasper.
- **1848** In Aug 1848 Harvey Hurst gave power of attorney to John Hurst to sell his land. Harvey had moved to Lee Co Iowa. John sold Harvey's 80 acres and his own adjacent 80 acres to the Adams family. This was the NE qtr of the original William Hurst homestead<sup>7</sup>
- **1848** Amelia T "consort of J Hurst" was buried in Jasper cemetery Dec 27, 1848 at the age of 25 years
- 1850 John Hurst is found in the 1850 Dubois census. Age 46, Merchant, born Tenn. Daughter age 8 named Mary J born in Indiana and daughter Flora H age 3 born in Indiana as listed as part of the household. Having a girl 3 and 8 is also very constant with marriage date in 1836 to Amelia 'T (Condicit)

MARY J., b. July 10, 1841; m., 1866, T. S. Johns, of Morristown,

N. J. They resided in Washington, D. C., where T. S. Johns

Was employed in the Treasury Department. She d. Aug.,

1877. He d. Nov 1877. No children.8

- 1852 John Hurst represented the Whigs at a congressional convention held in Petersburg
- **1860** John Hurst is not identified in the Dubois census in 1860. Flora Hurst is shown as 12 in the Spencer Co Census

- **1864** John gave power of attorney to L. Q. Debruler in 1864. John was residing in Washington DC. At that time per the court document<sup>9</sup>.
- **1866** John Hurst died in 1866 in Washington DC per Condicit family history. This was not confirmed by a search of Washington DC death index. He had remarried
- **1870** In 1870 Flora was living in the home of L.Q. Debruler
  - 1871 In Aug 20, 1871 Flora married Levi E. Riggs in Spencer Co FLORENCE H., b. Aug. 3, 1847; m., Aug. 2, 1871, Levi Riggs, b. June 18, 1828; d. Dec. 8, 1899. He was a soldier in the Civil War. She resides in Franklin, Ind. Had Anna R., b. Jan. 19, 1875; m., Oct. 19, 1893, m Adair Overstreet.

# **Mary Hurst**

- 1796 Born in Tennessee per 1850 Dubois Census, Bainbridge Co, pg 493 (Mary Debruler)
- 1812 1833 Mary married a Spradling. Date not known (Per George R. Wilson)<sup>10</sup>
- **1833** Mary had a daughter named Sophia Spradling. She is living with Wesley Debruler and Mary per 1850 Dubois Census pg 493
- **1839** In Dubois Co, 1839 Mary( Hurst) Spradling, John's sister married Wesley Debruler. Per George C Wilson's personal accounting in Historical Notes on Dubois Co (pg 442) he recalls an excellent dinner she had served him. He states they lived on the old Jasper Petersburg Rd near the Pike co line. This would have been very close to the William Hurst homestead.
- 1840
- **1850** Mary is listed in 1850 Indiana Dubois Census as Mary Debruler age 54, from Tennessee. She is with Wesley Debruler, age 63 born Nebraska, and they have Sophia Spradling age 17 born in Indiana living with them. . Sophia later married James Porter Downey, son of Alexander R. Downey, prominent minister. Nancy Downey age 50 F Nebraska and Porter Downey 20 M born in Indiana was listed on the adjacent line entry in the 1850 Census. Also living next to Mary is Robert Blair 52 M from Va. Robert purchased the land in 1855 that had been inherited by Albert and Jesse.
- **1860** Wesley Debruler is listed in the 1860 Census Dubois Co Bainbridge Twn pg 971 along with a John A. Debruler.
- **1905** Mary's grandson, Edgar A Debruler, received funds in Elijah S. Hobbs's will dated Feb 23, 1905 Dubois Co. Edgar is a son of Tom Debruler per the will.

# The factors that create doubt about the validity of the marriage of Mary of William and Anna Hurst to Hugh Dyer are:

- First of all the marriage information does not say Mary or Mary J, It says Jane Hurst married Hugh Dyer Sept 28, 1818 in Harrison Co<sup>11</sup>. It also states that Jane was not of the age of consent.
- . Second Hugh Dyer and Jane were living on the Abraham land along with the William Hurst JR. This is based upon Hugh Dyers entry in the 1820 Census being immediately adjacent to William Hurst Jr & Abraham Hurst. This land was located in isolation on the southern Dubois line next to Spencer Co. Why would a daughter and son in law move in with an uncle in a remote area when they could have gone to Bainbridge with her father just as Judith Hurst & James Payne did? Abraham had a daughter named Jane per a list identified by B. F. Hurst research. This person Jane has not been traced or further identified in a marriage. If this Jane, daughter of Abraham, was the one who married

- Hugh Dyer, then it would make sense for Jane & Hugh Dyer to move to the Southern part of Dubois. They would be locating next to James brother, William Jr, and her father Abraham
- William and Anna had presumably moved to Dubois by 1816. Having a young daughter under the age of 16 marry in 1818 in Harrison is possible but is also at least subject to question. Abraham didn't take the land until 1818. He may have stayed longer in Harrison than William did.
- I searched the Indiana marriage record but there is no Mary Hurst that married a Spradling listed. The marriage records for Dubois were destroyed prior to 1839. If she had been married in Dubois, there may be no way of knowing.
- Abraham had a large family. The list by reported by Herman Hurst from B.F.Hursts notes pg 49A lists a daughter named Jane, one of 13 children. The birth dates are stated as perhaps between 1792 and 1810 but not specific by individual.
  - I believe only source that the Jane Hurst who married Hugh dyer is the daughter Mary of William and Anna comes from the Clara Miles unpublished notes. What appears to be one typing called *Hurst Family History* (pg. 43) lists John Ezekial,- Sarah- David James -Mary (married Hugh Dyer) Julia-Harvey-Judith. Other notes on page 10 of an untitled but what may be an earlier draft of *Hurst Family* by Clara Miles lists Mary as a daughter of William and Anna but with parenthesis that qualify (perhaps the Mary that married Hugh Dyer). <sup>12</sup>

In summary I have not located any documents which would identify the Jane Hurst who married Hugh Dyer as the daughter of William and Anna Hurst.

### Possible relationship to William Henry Hurst

The only other Hurst for John and Mary to be related to in the area besides William and Anna and their children is William Henry Hurst. William Henry bought land in Bainbridge Township on August 23, 1836 shortly after the same time John Hurst was first detected. There are some coincidental circumstances in that William Henry and Wesley Debruler who married Mary sister of John are located immediately adjacent to each other. Wesley Debruler bought the land in 1842. This was a separate small area of settlement about 2 miles south of the William and Anna homestead. There is a William Hurst in Warrick Co who married a Spradling in April 1833. This is the same county that John Hurst married Amelia Condict in 1837.

Based upon a very close name, time line fit, and other circumstances known about William Henry Harrison Hurst I believe that the William Henry Hurst in Dubois is very likely William Henry Harrison Hurst, son of Beverly Hurst, son of Capt John by a second marriage. Thus William Henry would be a cousin (Refer to section on William Henry Hurst)

#### **Summary**

In conclusion, I believe John Hurst and Mary Hurst are the children of William and Anna Hurst as listed in the B. F. Hurst list. Other wise, you have to assume that John Hurst and also his sister Mary ended up in Bainbridge on their own. John was also 21 at the time he was first detected in Bainbridge and for him to relocate on his own at that age is not likely. George R, Wilson states in his book that virtually all migration into Dubois has ceased after 1825 until the Germans started arriving around 1837. There are no court records that show that John obtained a portion of the William Hurst land, as did Harvey, Charles, and Ira. But on the other hand he was close enough to Harvey to jointly maintain a portion of farm he bought from Ira for 14 years. He was also close enough to be named power of attorney for Harvey. There is also no court record which precludes John or Mary from being the possessor of the unaccounted for 70 acres of the William and Anna homestead. Elijah Hobbs ultimately owned this land and there is no record of a purchase of this land after the 1839 fire. Thus any land transactions presumably took place before 1839.

It total, the overall conclusion is highl probable that John and Mary are the children of William and Anna Morgan Hurst.

### Areas for further research

I understand there is an index of permission slips made by the Southern Indiana Historical Society by Walter Beanblossom for permission slips for marriages in Harrison Co. The court records say that the Jane Hurst who married Hugh Dyer in 1818 was under the age of consent. Obtaining the permission slip and determining if William Hurst signed or some one else could help answer the relationships. A request was made to the New Albany Library for a copy of the index. No index of marriages by Beanblossom was found for Judith or Jane Hurst. There is a very remote possibility that permission slips may be located at the Harrison Co Courthouse.

There is also a possibility of finding an obituary or will for John Hurst. The index of interments for Washington DC was searched and John Hurst was not listed. Perhaps his death was actually in New Jersey where his daughter had married T.S. Johns in 1866. A probate search was made by Richard Ellis at the National Archives and there is not a will for John Hurst in Washington. D.C.. A search of Spencer Co needs to be made where is other daughter Flora was living and his power of attorney L. Q. Debruler (the judge)

#### Other Children of William and Anna Hurst

# **Judith Hurst**

Judith married James Payne December 29,1814 in Harrison Co<sup>1</sup>. They also homestead immediately adjacent to William and Anna Hurst in Dubois and purchased 160 acres on Sept 30,1816 in Township 1, Section 23 NWNW corner. <sup>2</sup>

The marriage record in the Harrison Co courthouse states that James Payne was of age but makes the section for Judith is left blank. This could mean she was not of the age of consent. It appeared that those of age were noted as such on other pages. Children and descendents are:<sup>3</sup>

# Ezekial, James, Daniel & Roger

The remaining male children of William and Anna: Ezekial, James, Daniel, & Roger<sup>4</sup> have not been detected at all in Dubois or Pike Co in Indiana. There is also no further information published that further identifies them except for the initial lists of name by B. F. Franklin In looking at the Census information between 1810 and 1820 it appears that two of the William male children may have died before 1820. The remaining names of Daniel and Roger are quite possibly Charles and Ira. There is a Daniel Hurst who married a Susanna Howard in Spencer Co inn 1831 but if this is the same one or not is not know. Abraham had a large family with children marrying in that area so identification is not easy.

#### Sara & Julia

These two individuals have never been detected in Dubois or Pike Co There is also no published or available information on these individuals beyond the original B.F. Hurst list of names<sup>5</sup>. It is possible that Julia and Sara either died or married with out any remaining records today. The marriage records from Dubois during this period of time would have been destroyed in the fire. The

Also Abraham had a daughter named Julia so that could be his daughter here

# 1839William Henry Hurst, Jesse Hurst, Albert Hurst

# **Documents linking Albert and Jesse Hurst to William H. Hurst**

Based upon land and tax records which have every appearance of being an inheritance I believe that Albert and Jessie Hurst first identified in the 1850 Census in Pike Co as minors residing with a William Black are children of William Henry Hurst.

# **William Henry Hurst**

Who William Henry Hurst was or where he came from is not directly identifiable. He is not listed in either the 1830 nor the 1840 Indiana Census so information about his age, number of children, etc is not known making positive identification difficult. Based upon circumstantial evidence he very likely to be William Henry Harrison Hurst, son of Beverly. Beverly is a son of Capt John by a second marriage and was residing in the neighboring county of Spencer

The primary information known about William Henry Hurst comes from the historical land maps showing that a William H. Hurst entered the SW1/4 SW1/4 Sec 10 of TS1 R6W on Aug 23, 1836. The deed was issued to William Henry Hurst by the land patent office Feb1, 1839¹. The middle name is identified as Henry in the biography of John Hurst as recorded in Wilson's Historical notes and is also listed as William Henry Hurst on the land patent. There is a William Henry Harrison Hurst (b 1817) who is the son of Beverly, Son of Capt John Hurst by second marriage to Mary Barksdale. Beverly died in Spencer Co in 1853². There is a William H. H. Hurst who married a Nancy Jane Hoskins May 3, 1842 in Spencer Co³. There is a William Hurst in the 1840 Spencer Co census close to Beverly in entries who is likely to be William Henry Harrison Hurst. He is listed as a single male age 20-30. There is a death of a William A Henry Hurst, age 33 in Spencer Co in the 1850 Mortality schedule (Info from Douglas Quebbeman) These may not be the same individuals but the ages match in general and are consistent with a death of William Henry Hurst inferred by delinquent taxes owed by his heirs in 1850 for property in Bainbridge Township, Dubois Co.⁴

The hypothesis and chronology is:

**1815-1817** William Henry Harrison Hurst son of Beverly was born some where in 1817 time frame. This comes from the "Hurst Family" by Clara Miles. The notes and different revisions of the "Hurst Family" vary. In come cases only the children names are listed, in

one version the birth years are hand written in a chronological order. I suspect the birth year is an estimate.

**1833** There is a William Hurst who married Rachel Spradling Warrick Co April 1833<sup>5</sup> If this is the William Henry Harrison Hurst he would have been 16 depending upon the accuracy of the 1817 date<sup>6</sup>

1834 An Albert Hurst age 16 was born in Indiana (1850 Pike Co Indiana Census)\*

1836 A Jessie Hurst age 14 was born in Indiana (1850 Pike Co Indiana Census)\*

\*The children were residing with the William Black family in the 1850 Census in Pike Co.

**1836.** George R. Wilson identifies a William Henry Hurst as entering land Aug 23, 1836 in Bainbridge Twn Ship Dubois. This is where Mary Hurst a Spradling by Marriage was possibly living She is identified in this area via a marriage to Wesley Debruler Dubois in Dec, 1839 who also had land next to William Henry Hurst. George R. Wilson also states that she was living on the Old Jasper/ Petersburg rd which would be in this area. John Hurst's in law (John H. Condicit) is also in this area. John married an Amelia Condicit in Warrick Co in 1836

1839 William was issued a land grant for 40 acres in the name of William Henry Hurst on Feb 1,1839. In order to own land at the age of 21 William would have to been born no later than Feb 1818

**1840** William Hurst does not show up in the 1840 Dubois Census

**1840** A William Hurst appears in the 1840 Spencer Co Census on page 373 as a single male age 20 – 30. Beverly Hurst also appears in the 1840 Spencer Co Census on page 375 Presumably this William Hurst is William Henry Harrison Hurst Beverly's son

**1840** There is a William Black listed in the 1840 Pike Co Census. A check needs to be made to see if the listing of children by age category includes Albert and Jessie in addition to the Black children identified in 1850 Census. Giving children away after loss of a spouse was common in this period of time.

**1842** A William H.H. Hurst marries a Nancy Jane Hoskinson in Spencer Co on May 3, 1842. Other members of Beverly's family Julia Ann also married into the Hoskinson family. (Thomas Hoskinson, Spencer Co, 1841)<sup>8</sup>

**1844** George F Hurst is born per 1850 Census

**1847** Mary J Hurst is born per 1850 Census

**1849** Julia A Hurst is born per 1850 Census

**1850** There is no William Hurst listed in the 1850 Census in Spencer Co or Dubois Co

**1850** There is a William A. H. Hurst listed in the mortality schedule for Spencer Co harbor pilot listed as dying of pneumonia age 33<sup>9</sup>

**1850** Nancy J (Hoskinson) Hurst age 28 is listed in the 1850 Census Roll 177, pg 76 line 1030 as living in the household of Mary Hoskinson age 69. With 3 Hurst children, George F age 6, Mary J, age3 and Julia A, age 1

**1850** The tax records for Dubois state that the heirs of William Hurst owe taxes on land in Bainbridge Township Dubois Co. This is where William Henry Hursts land was located.<sup>10</sup>

**1855** In 1855 Albert (Age 21) sells 40 acres of the 40-acre land plot that was issued to William Henry Hurst<sup>11</sup>

**1857** In 1857 Jessie (Age 21) sells 20 acres of the land plot that was issued to William Henry Hurst <sup>12</sup>

. There could be 4 separate William Hursts here.

- 1 William Henry Harrison Hurst son of Beverly, married Ann Hoskinson when he was approximately 25 and presumably died some time between 1849 and 1850 at the age of 33
- 2 A William Henry Hurst, origin unknown, who had land in Dubois and left two children in Pike Co and died some time between 1839 and 1850. He would have been born some time before 1818 to have owned land,
- 3. An unknown William Hurst in Warrick Co who married a Rachel Spradling and disappeared from any further detection. Hursts were not part of the Warrick Co population in general.
- 4 A different William A. H. Hurst who died in 1850 in Spencer Co and was never previously detected

There were not lots of Hursts in this remote area in the 1830's and all those that were there seem to be part of the Capt John family or decendants in some manner. Considering the limited geographical region (adjacent counties), very good chronological fit of events, and very close matching of names, it seems highly probable that all four people are actually one.

# A hypothesis that could tie all the above information together is

William Henry Harrison Hurst, son of Beverly, married a Rachel Spradling from Warrick Co. He and Rachel had two children Albert and Jessie. William located in Bainbridge Co Dubois Co possibly because of in law relationships with the Hurst's & Spalding's. Rachel died some time in 1838-39 time frame. He gave the kids up and moved back to Spencer co in the area of his father and other relatives. He remarried Mary Jane Hoskins in 1842 and had 3 children in 1844, 1847, and 1849. He died in 1850. His children Albert and Jessie sold his land in Dubois when they became of legal age. Albert was in Green Co Arkansas at that time and died in Carroll Co Ar in 1875

### Albert Hurst (1834-1875)

Albert was born Jan 19, 1834 in Indiana. He married Mary Ann Demet about 1857 in Green Co Arkansas and died in Caroll Co Arkansas about 1875. Albert is identified in the 1850 census as living with a William Black age 34 and wife Mary in Monroe Township, Pike Co. Jane Hurst had married a William Black in Dubois 1840 and is a presumed heir to Charles. This is unlikely to be the same William Black who married Jane due to an age but there may be a family connection.

The census information stated Albert was 16, born in In, and was a laborer. Jesse Hurst (presumed brother to Albert) was also living with William Black and was 14.years of age and born in Indiana. Per the 1850Census

Albert is next identified in the index of deeds and a deed dated Jan 20, 1885 where he sold 40 acres of the SW Qtr SW qtr of Sec 10 T1S R6W to Robert Craig for \$55 on Jan 20,1855. Albert had moved to Barry Co. Mo. (Close to Kansas City) and then on to Green Co. Ark. Per the court documents this is the land owned originally by William Henry Hurst. Albert would have been 21 when he sold the ground. The tax book did not show any taxes being owed by the heirs of William Hurst in 1855. The logical assumption is that Albert obtained the land through an in inheritance and sold it when he became of age.

His descendants are known and are listed in family tree CD#11.

# Jesse Hurst

Albert's brother, Jesse, is also identified in the index of deeds as selling 20 acres of the SW Qtr of SW qtr of Sect 10, Township 1 S, Range 6 West. to Zachariah Risley on Dec 26,1859. This is the same 40-acre section of ground that Albert sold in 1855. Jesse would have been 22 or 23 at this time based upon the 1850 census definition of his age. Something does not make sense in this transaction or the recording of it. Jesse to have owned this land would have had to purchase it from the owner presumably Robert Craig and then resold it. There would be no logical reason for this particularly considering the transaction is for 20 acres which is ½ of the section. Albert and Jesse splitting the land would have made more sense. Perhaps Robert Craig was acting as a guardian for Jesse. Or perhaps the land was never surveyed and split as would have been done today.

# Jired Hurst (1840 census)

# Correction to Federal Index for 1840 Census for Indiana - Jired Hurst is actually Ira Hurst

\_ The 1940 Federal Census Index lists the first name of Ira as Jired. The specifics of the census show that Jired has the same age as Ira, his wife was the same age as Phoebe, his two children and gender match that of Ira's. Furthermore, the Jired household is numbered and exactly next to the household of Robert Brenton, Ira's father in law. Ira purchased a piece of land from Robert Brenton in 1842, just prior to Robert's death and I believe he was living on that ground at the time of the 1840 census.

The German immigrants typically wrote an I as a J during this period of time.

#### **Abraham Hurst**

Abraham purchased land on the southern border of Dubois next to Spencer Co Sec 32, Township 3 S, R 5W on May 5, 1818. He is also listed in the 1820 census and is the brother of William. Based upon information from Douglas Quebbeman, Abraham was in Harrison Co in 1830 and died in 1872 in Troy Co, In.

His family has been traced and includes a Bill Hurst currently residing in Newburg In.

# **Squire Hurst 1860 Census**

Per census Squire was born approx. 1822 in Tenn. His wife Doicia was born in Ky. They had 6 children ages 16 to 1.

Mary Hurst age 65 who was born in Va. was also living with him. This person is most likely a relative in some manner, perhaps a mother? Who Squire is not known. He is possibly out of Fleming Co where similar names were utilized in the Hurst line in that area.

#### James W. Hurst

The relationship if any of this James to the James who shared the Charles Hurst land is not established. James W Hurst is residing in Pike Co per the 1860 census. He is identified as farmers age 38 (Born 1822 in Ind.). A wife named Catharine age 30 from Ky. They have 7 children listed James F 14, Cloe 12, Marilda, 10, Lavinna 8, Sarah 6, Susan 4, Mahala 2. All the children except the first were girls. No other information is known and he is not present in the 1850 Pike Census. Squire Hurst is also in the same Co in the 1860 census. There is a possibility they might be from the Fleming Co Hurst's but this is pure speculation.

#### **German Hurst settlers**

Bernard, Joseph, Sylvester, and John C are identified in the Wilson's Historical Notes as being German ancestry. The 1860 Indiana Historical Society lists Bridget, Cornelia,

Edwards, Robert, & Thomas as being German descent. Other Hurst's such as Peter, Frederick, Grosvatter. are suspected of being German origin. Most of the Germans started arriving in the 1840's and located on the Madison Township line. They are listed by year they appear in the census on the chart of known Hursts in Dubois & Pike County
