"This Indenture Tripartite made this Thirty first day of August in the year of our Lord one

thousand seven hundred and ninty eight between «b»T«b»homas Berry Sr of the one part, Samuel McChesney of the other part, and Esther Berry, wife of said Thomas of the third part.«b» «/b»Witnesseth that whoever the said Thomas Berry being late the proprietor of a certain tract or parcel of land lying in the County of Washington and State of Virginia and being arrived at an age when no Burgess capable of superintruding that the management of a plantation has by and with the amount of the said Esther his wife alienated and sold the same unto a certain David McCord for the consideration one thousand three hundred thirty three dollars and thirty three cents for which sum the said David McCord with Thomas Berry his security has entered into two seperate obligations, the one for eight hundred eighty eight dollars and eighty eight cents and payable to David Lowery «b»and Samuel McChesney within six years after the death of said Thomas Berry Sr: «b»to be applied or shall be devised by his last Will and Testament, the other for four hundred and forty four dollars thirtysix cents payable to Samuel McChesney within six years after the death of the said Thomas Berry Sr. for the use, interest and purpose hereinafter excepted. And whosoever the said Thomas Berry in consideration of his love and affection for the said Ester his wife and in consideration of her having relinquished her right Domain in the land herein before mentioned & being desireous of making provision for the said Esther his wife after his death doeth Grant covenant and agree that aforesaid sum of four hundred and fortyfour dollars and thirty six cents part of the consideration of the land be sold to David McCord and for which an obligation bearing date the twentyfourth day of August payable within six years after the death of said Thomas Berry Sr: unto Samuel McChesney shall vest in the said Samuel McChesney and that he shall have right to collect and receive the same. And the said parties agree that from and after six years after the death of the said Thomas Berry the said sum of four hundred and forty four dollars and thirtysix cents shall be the sole property and at the absolute disposal of her the said Esther and that the right to the said sum of money herein vested in Samuel McChesney is understood as a trust for the use behalf and benefit of her the said Ester Berry from and after the period aforesaid and the said Samuel McChesney consents and agrees for himself his heirs executors & administrators that from and after the period aforesaid he will relinquish all right or causes of right which he has or may have Same or equity to that said sum of money. In witness of which the parties have hereunder set their hands and affixed their seals the day and year above written.

"Thomas Berry (1718 - 1798) was probably born in northern Ireland in 1718, although several sources suggest that he was born in either Scotland or Pennsylvania. The best available source for his birth date and place is a newspaper article from the late 1800's with the data apparently supplied by a grandson of Thomas Berry."

" Most sources . . . indicate that Thomas Berry was married twice, although there is some disagreement on the names of the two wives. The surname of the first wife, Buchannon (1718 - 1755), is known from a number of sources, and, while several researchers have suggested a number of given names, (Mary, Esther, Rebecca), no documentation has been found, to date, to support any of these claims. On the other hand, the first name of his second wife, Esther (1730 - 1822) appears in a significant primary sources, but there is no information on her surname. Thomas Berry is believed to have married his first wife ? (unknown first name) Buchannon sometime around 1738 or 1741, and after her death, married Esther Ward on 16 March 1757."

Berry Family researcher Jim Berry has written:

"From Augusta Parish Vestry Book: Thomas Berry (1718 - 1798) was born in either northern Ireland, Scotland or Pennsylvania. While the available sources appear to disagree on the place of his birth, they all agree on the date. The same sources also note the existence of two wives, Mary Buchanan Esther Rebecca Buchanan (1718 - 1755) and either Esther McClure (1730 - 1822) or Esther Ward, although there is no primary source documentation for any one other than Esther, and only her first name can be verified. In the case of his second wife, it is entirely possible that the names McClure and Ward represent a maiden name and a married name from an earlier marriage. Thomas married Mary/Esther Buchanan sometime around 1738 or 1741, and after her death, married Esther McClure/Ward on 16 March 1757. As noted above, the 1742 Augusta County militia lists do not contain any Berry family members, which probably defines a lower limit on the date that the Berry family members emigrated into the area. Since the first documentation of Thomas Berry's presence in Augusta County is from 12 April 1748 (where he is, apparently, already a land owner), he, apparently arrived in the area sometime between 1742 and 1748. He can be traced with certainty through Augusta County records until 17701771, when he left the area to settle on Wolf Creek, a tributary of the Holston River in Washington County, Virginia, where he lived until his death in 1798.

Berry, £56.12.6, 168 acres purchased by Arthur from David Kerr on Capt. Joseph Kennedy's Mill Creek, part of Borden's tract; corner of Robert Gray's line; McNut's new line; corner of Francis Beatey. Jeane (mark)Kennedy. Livery by a rail in the fence. In 1772 Thomas Berry and family picked up stakes, and moved to Wolf Creek, a tributary of the Holston River in Washington County, Virginia. Here he became involved in an effort to establish roads in the area, and may have also been wounded by Indians in a gunfight. It is not clear at this point if this was Thomas Berry, Sr or his son, but since the Washington County court records typically differentiated between the two as junior and senior, it appears that it was Thomas senior that was wounded. In 1780 he was elected to be a Lieutenant in the local militia a few months after the Battle of King's Mountain (which is discussed later in the report). Thomas also served on several juries and inventoried/appraised estates, and sold some land to one of his children during the 1780's. He also provided food and horses to the army during the Revolutionary War, and was paid for his services. It should also be noted that Thomas Berry was a slaveowner, since he mentioned several of them by name in his will. Of particular interest is the fact that he stipulates that a particular slave is to be set free upon his death. While it may not be true in this instance, in many cases throughout the south, it was the practice of many slave owners, upon their death, to set free slaves that they had grown up with and with whom they had been friends and companions throughout life. It was also quite common to set free slaves who had been their mistresses, as well as the children these mistresses had borne from the master. In this case, a female slave named Tawney is to be set free upon his death, whereupon she is also to be awarded a milch cow. This is quite a gift for a person considered only as property. It is quite possible that Tawney was either his mistress or his daughter from an unnamed mistress. Her name, Tawney, also suggests that she is of mixed ethnic origin. Tawny is a term denoting a light brown color, and in reference to a known slave, it suggests that Tawney is the result of white and black racial mixing."

""From Marie Loughlin(Berry Team) ""in Jan 2004 proof that this Thomas was in fact born in Northern Scotland or Ireland and he and his son James(b 1740) immigrated to this country from Northern Scotland through Ireland proving that Frank and Ethel Berry were right.(She sent me over 200 documents)

Question to Ethel 21 Aug 1994. Was Thomas Berry (1718-1799) born in Ireland ? Answer-Yes but--- You'd have to go to Ireland to prove it. Ethel was 101 years old at the time. I also asked her if she could still fix a car if she had to. She smiled and said yes. Frank owned the garage there in Lewis and she used to help fix the Model T's. I was in Lewis attending the 78th annual Berry reunion, 8 Aug 1994. In trying to prove my first cousin once removed, Frank and wife Ethel right I think Thomas was born in Middlesex Co 5 Sep 1727-Lyle Thomas purchased land from his brother William & wife Jane McGill 1 Mar 1753, last land transaction in Augusta Co Va 21 Jun 1763 Thomas & Esther to James Berry (son of Thomas) delivered April 1765. Probably moved to Wash. Co. area at this time.- Hobart berry (now aware that part of Augusta Co was renamed Wash. in 1772) I now am convinced that this the same Thomas that was born and baptized in Middlesex county in 1727. There were just too many Berrys in Augusta County for most of them not to have been related. I agree that they probably had three children when

they came to Augusta County and Thomas was probably born shortly after they arrived about 1750. We know of several property transactions starting in 1753 and continuing several years. Esther Buchanan died in 1755 and Thomas married Esther (McClure) Ward and had 7 more children by her. He died with a will of record in 1799. I think Thomas' father had more children after he moved west but I think it was east of the Holston Valley area and I haven't been able to locate a will or proof of this. Hobart and Jim Berry both think there were several more brothers and I think so too, possibly Charles, William, Francis, & George. There are two books written one by William Elwood Berry (The Berry Patch) I have a copy. Also a book written by Stanley Berry (Basket Full of Berry's). I borrowed it from a cousin for a short time. Both of these authors give credit to Frank and Ethel Berry of Lewis, Ia. Frank was my first cousin once removed. I knew him and Ethel all my life. I met Stanley in Lewis when he was researching for his book. Elwood has the will of Thomas (d 1799) in his book. I think the William that Thomas got his first land from was his uncle and part of the reason he came to the Holston Valley.
