The document is written in a script called "Secretary Hand." This transcription adheres to the spelling, punctuation, and lineation of the original, with these exceptions: superscripts have been lowered, insertions incorporated into the text, and in several minor cases, bracketed words added in place of confusing abbreviations.

Terms used in the deed include:

enfeoff, in English law, to give freehold property or land in exchange for a pledge of service; *hereditaments*, in law, any property that can be inherited, whether corporeal (physical or tangible) or incorporeal (as a rent or right of way);

messuage, a dwelling house with the adjacent buildings, courtyards, and other adjoining lands used in connection with the household;

perch, a unit of measurement equal to 5½ yards, based on the length of a surveyor's pole, also called a rod or perch;

quitrent, a small annual fee paid by a landowner to the proprietor who had conferred the holding; and

scituate, an archaic version of situate (situated).
