PREFACE

Raymond David Wheeler and Gordon Boyce Wheeler have collaborated to jointly author Parts B and C, which detail the descent of Stedman Cyrus⁹ Wheeler from George¹ Wheeler of Concord, Mass., and Thomas¹ Wheeler, Sr., of Concord, Mass., and Fairfield, Conn. Gordon Boyce Wheeler was primarily responsible for the information on the descendants of Stedman Cyrus Wheeler and their families.

Part A of this work was authored by Raymond David Wheeler, based upon his research into the Wheeler Family of Cranfield, Bedfordshire. His work, *The Wheeler Genealogy, The Wheeler Family of Cranfield, Bedfordshire, Settlers of Colonial New England*, covers the Wheelers of Cranfield, and their descendants in colonial New England.

The authors wish to credit Gleason Wheeler Ayers for providing the information on the Ayers family, and for his interest and cooperation.

A WORD ABOUT FORMAT

New England Historical and Genealogical Register format is used. References follow each factual element to avoid footnotes, which could be confused with the superscripts which denote each generation. Each major listing of a person is followed by a line of descent.

REMEMBER THE CALENDAR

Between 1582 and 1752, England and its colonies remained on the old Julian calendar, while Catholic countries adopted the Gregorian calendar, which in 1582 corrected an error of ten days and began the new year on 1 January. For this work, old style calendar was in use, whereby the year began on the 25th of March. March was the first month of the year. To prevent confusion, a standard double dating notation is used for the period of 1 January to 24 March, first showing the year of the event, followed by the number of the year that would begin on 25 March. Thus the day after 31 December 1623, would be 1 January 1623/4. Similarly, the day before 25 March 1624, is recorded as 24 March 1623/4. The records themselves frequently used this distinction. INTRODUCTION

In his article, "The Father of the Concord Wheeler", Donald Lines Jacobus set forth the family of Thomas Wheeler, "the elder" of Bourne End, Cranfield, Bedfordshire (*The American Genealogist*, 14[1937]:1-4; hereinafter *TAG*). This corrected a part of the English ancestry of the Wheelers given two years earlier by Homer W. Brainard, in his, "Captain Thomas Wheeler and Some of His Descendants" (*TAG*, 12[July 1935]:4). Jacobus based his conclusions upon the 1627 will of Thomas Wheeler, which was transcribed in his article. One of America's most distinguished genealogists, Jacobus had earlier provided extensive coverage of the Wheelers in his *The History and Genealogy of the Families of Old Fairfield*, issued in 1930 - 1932.

As pointed out by Jacobus, the elder Thomas Wheeler was father of Thomas Wheeler, Sr., of Concord and Fairfield, of (Capt.) Timothy Wheeler of Concord, of (Lieut.) Joseph Wheeler of Concord, of (Sergt.) Ephraim Wheeler of Concord and Fairfield, of (Capt.) Thomas Wheeler, Jr., of Concord [and Fairfield, Conn. Colony; Westchester, New Netherlands Colony; and Paugusett, New Haven Colony], and father-in-law of Obadiah Wheeler of Concord. He was also the father-in-law of Allen Breed of Lynn, Mass.

The will did not mention George Wheeler of Concord (identified among others by Brainard), so Jacobus reflected that the George Wheeler, son of Thomas Wheeler, baptized at Cranfield, 28 March 1605, must have died young. He gave that probable fate also to the Thomas Wheeler, son of Thomas, baptized 20 November 1603.

In a series of articles, "The Wheelers of Bedfordshire and New England", John Insley Coddington provided much additional illumination on the many Wheelers from Bedfordshire. He provided full transcriptions of many wills, among which was that of John Wheeler, "the elder" of the Town End, Cranfield - another, "Father of the Concord Wheelers." Coddington updated the Brainard article to show that John was the father of Mary (Wheeler) Barrett, wife of Richard of Southampton, L.I.; Elizabeth (Wheeler) Halsey, wife of Thomas of Southampton; Sarah (Wheeler) Nash [wife of Robert Nash of Boston], Isaac Wheeler of Charlestown, and Obadiah Wheeler of Concord.

Even with Coddington's series of articles, the identification of George Wheeler's father remained elusive, and George's spurious first wife was not removed (TAG, 27[1950]:35).

Unidentified still was the father of Thomas Wheeler of Lynn, Mass., and Stonington, Conn.., who died 6 March 1686[/7], aged 84.

The Genealogical and Encyclopedic History of the Wheeler Family in America ([1914]. 17), incorrectly suggested that George Wheeler of Concord, was a brother of Captains Timothy Wheeler and Thomas Wheeler, basing this upon the "English records" which showed that George Wheeler had a brother Thomas Wheeler. Not explored was the possibility that George Wheeler of Concord, was brother to Thomas Wheeler of Stonington, or for that matter, any other Thomas Wheeler.

In his work from about the same period, *The Wheeler Families of Old Concord*, *Mass*. [1908, reproduced for the Concord Free Public Library in 1970], George Tolman thought that George Wheeler was Capt. Timothy Wheeler's uncle, and that it was probable George and Obadiah Wheeler were brothers. Tolman's work complemented *Wheeler Family* very

nicely for the family in America, but he did not have access to a good transcription of the English parish registers.

One such good transcription of the parish registers for Cranfield, is volume 27 of the Bedfordshire Parish Registers, edited by F. G. Emmison. From it may be plotted a time sequence of the baptisms of the children of each Thomas Wheeler. Occasionally, the parish register would tie the Thomas Wheeler to his occupation or the locale where he resided at Cranfield. At first, Thomas Wheeler, whose will was given by Jacobus, was called, "of Wharley End", then when his son married and was having children, the elder was called, "of Bourne End", and the son became, "of Wharley End" [this latter "of Wharley" was transcribed "of colorly?" in the Jacobus article]. Thus it is a simple matter to determine which children belong to Thomas Wheeler of Bourne End, and which belonged to his son, Thomas Wheeler of Wharley End. With five children of Thomas Wheeler left over, belonging neither to Thomas Wheeler of Bourne End, nor to his son Thomas Wheeler of Wharley End, we find the third Thomas Wheeler's family.

Fortunately, the entry for one of those children identified this third Thomas Wheeler as Thomas Wheeler, "of the Town End" at the baptism of his son Richard on 13 June 1614. Each of the other four children fit into a logical sequence to form a family unit distinct from that of Thomas Wheeler of Bourne End and his son Thomas Wheeler of Wharley End. The existence of this third Thomas Wheeler is verified by the 1626 listing of land holders at Cranfield, which shows him as being of Austin Allen [Close] on the Buckinghamshire border.

About one hundred descendants of the Wheelers of Cranfield came to America in 1638 and 1639. Some arrived later. They were active in the settlement of New England. Their descendants form perhaps the single largest family in North America.

Here we focus on the descent of the Honorable Stedman Cyrus Wheeler of Waterbury, Vermont, and document the place of his descendants in the Wheeler family.

PART A

DESCENT FROM HENRY WHEELER [c1503-1557]

OF CRANFIELD, BEDFORDSHIRE, ENGLAND

1. Henry Wheeler of Cranfield, Beds., was born about 1503, and died between 27 May 1556, the date of his will, and 17 March 1556/7, the date his will was proved. He married, say 1525, an unknown first wife. He married second, Isabel Allen, daughter of Thomas Allen of Cranfield (Will of Thomas Allen, 13 Aug. 1557, Beds. Rec. Off. File, ABP/W 1557/254, and will of Richard Allen, Junior, 12 Aug. 1556, Beds. Rec. Off. File ABP/W 1558-9/48), born say 1524, and died between the date of her will, 24 November 1570, and the date it was proved, 21 February 1570/71.

Henry Wheeler's will:

"In the name of god Amen In the yere of or lord 1556 the vxii day of May I henry wheler of Cranfeild in the Cont of bedff husbandman seik of body But of pfytt mynd & memory do make & ordeyne this my prsent testemet conteynyng therein my last wyll in manr & forme folowyng ffyrst I do beqthe my soule to allmyghthy god my maker & to hys sonne or salveor Jesus Chryst my Redemer & to or blessed lady saynt Marye & to all the blessed company in heaven And my body to be buryed in the churchyerd of cranfeild aforesayd Itm I wyll to the hyghe alter for my tythes & oblacyens forgottten - iiiid Itm to the church of lyncoline - iid Itm I will to the glassyng of the church wyndowes - xxd Itm I wyll to the mendyng of the pavement in the church - xxd Itm to the mendyng of ye church bell clapper xxd Itm to the bells iis Itm I wyll to the cawsey - iiis iiiid Itm I wyll to thoms wheler my sonne all the cattell yt he hath of myne except the ii kyeu of hys brother wyllms & of hys brother Johns Itm I wyll to the sayd thoms fyve pounds of money Itm I wyll to henry Ryng my godchild - xiid Itm to henry wheler ye sonne of John wheler - xiid Itm to my godchyld at basterfeilds - xiid Itm to every other of my god chyldren - xiid apece Itm I wyll to be given to the moost porest peple in the towne - vis viiid the Rest of my goods moveable not beqthead my detts payd & my legacs pformyd I gyve to Isbell my wyfe whome I make my full & treu executrix in this behalf & she to dyspose the same goods amongst my chyldren at her dyscretyan & for the health of my soule & all crystn soules Itm I wyll that wyllm wheler my sonne be overseer to se this my last wyll & testement trewly & faythefully pformede & he to have for hys paynes - xiid wytness Sir Robert harreson curatt Rycherd wheler wt other" (Will of Henry Wheeler, Beds. Rec. Off. File, ABP/W 1556/115).

Isabel's will yielded a number of relationhips, but she did not tell what relationship any of those named were to her:

"In ye name of god ame in the yere of or Lord god 1570 the xxviiii day of november I Isabel wheler of Cranfeld in the Cont of Bedd wydowe weil of Bodie & sole & pfytr of mynd and Remebrance make & ordeyne this my prsent Testement & Last will in forme following ffyrst I bequethe my soule to almyghtie god and all the holie copany in heaven and my bodie to be buryed in the churche yerd of Cranfeld aforesayd Itm I bequehte to the churche of lyncolne iid Itm I will to the bells in Cranfel iis Itin to the highe ways there - iis Itm to the pore peple in Cranfeld aforesayd - vs Itm I will to agnes wheler & Ales wheler dowghters of Thomas wheler on lyttell brasse panne & ii platters * a Canstyk Itm I will to Rycherd wheler Sonne of willm wheler a charger of pewder Itm I will to margaret wheler dowghter of willm wheler a pewder platter Itm to Margaret willm wheler dowghter Sonne of will wheler it makt arks & an old presse a fatt & the great pot & a saltyng keog Itm I will that the xs wch is in the handes of willm Johnson to mychael Baker Sonne of edward Baker or els a bullok for the same money & to be browght up to thuse of the sayd michaell Itm I will to agnes & ales Baker dowghters of edward Baker a euwe bullok to be bredd & brought up to their uses Itm I will to heary wheeler Sonne of Thoms wheler a bullok to be brought up by Thoms wheler & the increase thereof to Isabel wheler his Syster Itm I will one bullok to the chyldren of willm baker agnes & Thoms & to be bredd & brought up to their uses Itm to Rycherd wheler sonne of willm wheler a bullok to be bredd & brought up to his use Itm I will to Jone Johnson an ewe sheep Itm to anne Johnson a boltyng fatt or els iis iiiid of money Itm to John Wheler sonne of heary wheler an ewe sheep & a kynnell in the loft The Rest of all my goodes not bequethed my legacys pformed & fynehall charges ended I will & give to Jone wheler dowghter of Thoms wheler whom I make my sole exect to se this my last will trewly pformed & fulfilled Itm I will to all my godchildren iiiid apece Itm I will Robert Styrmy to be Supervisor to this my last will & to have for his paynes xxd Thes beyng witness Thoms hamerton curat Willm Syllys Thoms fuller Willm odell Willm Baker & Robert Styrmy" (Will of Isabel Wheeler, Beds. 2. THOMAS^B WHEELER (*Henry*^C) was born at Cranfield, Beds., say 1526, and was alive in 1569/70, when named as supervisor of his brother William's will. Isabel Wheeler, in her 1570/1 will gave a bullock to Henry Wheler, son of Thoms Wheler, and named Henry's sister Isabel Wheler.

At the time, there were few Henry Wheelers, so the one mentioned by Isabel probably was the one who was later of Salford. That Henry Wheeler was shown by the will of George Wheeler, dated 31 May 1688 (TAG, 28[Jan. 1952]:146) and the will of George's brother William, dated 7 Feb. 1671/2 (*ibid.*) to be the brother of John Wheeler of East End, Cranfield, father of George and William.

George Wheeler of Kempston is placed in this family because his two sons, Thomas and William, were called kinsmen by the 31 May 1688 will of the other George Wheeler, and they were the ones who were called of Burkett [sic] in the parish of Wing, Bucks.

This will, abstracted in TAG (28[Jan. 1953]:140-141, indicated that Robert Styrmy was, of Hedborae. There is no of in this phrase, so what seems to be meant is the feudal title, Head Bordar.

4. THOMAS^A WHEELER (*Thomas*^B, *Henry*^C) of the Town End, Cranfield, Beds., and also of Austen Allen Close at Wharley End, Cranfield, was born say 1578, and was possibly

buried at Clerkenwell, St. James, Middx. [London], 21 January 1640/1 (A True Register of All the Christenings, Marriages, and Burialles in the Parishe of St. James, Clerkenwell from the Year of Our Lorde God 1551, Robert Horenden, ed., {London, 1884 - 1891], v. 4, 245; hereinafter PR). The names of his wives are unknown. He perhaps married first at Chalgrave, Beds., 13 April 1600, Dorothy Holloway (PR, 18), daughter of Hugh Holloway, baptized at Bedford, St. Mary, 13 October 1574 (IGI). He perhaps married second, at Clerkenwell, St. James, 5 November 1625, Jane Mitchell (PR, v. 3, 55), and perhaps married third, there, 30 November 1631, Elizabeth Claye (ibid., 62).

This Thomas Wheeler was mentioned as a distinct individual at the baptism of his son Richard on 13 June 1614 (PR, v. 27, 2), and in the 1623 land survey of Cranfield.

In the 1623 land survey by Benjamin Hare, Thomas Wheeler, "of Alsnaline" was one of the three Thomas Wheelers mentioned. Of the other two, Thomas Wheeler, Senior, was listed with his house at an unidentified locale, while Thomas Wheeler, Junior had the site of his house listed as being at "Wharley". Other references place the site of Thomas Wheeler, Senior's house at Bourne End.

The term "Alsnaline" applies to the sixteen acre close at Wharley End, Cranfield, called "Great Austen Allen" lying on the border of North Crawley, Bucks. This Thomas Wheeler had over 25½ acres at Wharley End, including eight and ¾ acres of Bailey Gates, also lying on the border with Buckinghamshire. In addition, he held from George Purrier, another eight and ¼ acres with the house and closes.

No will has been found for this Thomas Wheeler, and the grouping of his children at Cranfield has been determined by working backwards from Richard, and attributing to him those children of Thomas Wheeler who did not fit into the families of the other two Thomas Wheelers.

The Clerkenwell, St. James connection is suggested to frame the relationship of John Wheeler of New London, Conn., to Thomas Wheeler of Stonington, Conn., who would seem to be Sarah (Wheeler) Williams', "uncle Wheeler", who invited Sarah's father to New London.

Any first wife probably died before 1600, the year parish registers began. He probably married second, say 1599, REBECCA [-----], whom he named in his will.^[2]

^[1] While pondering the reason why Samuel Saltonstall died at Concord, Mass., 21 January 1695/6 (VR, 57), the only one of that name on the vital records, we wondered if he came from a neighboring town because he had kin at Concord. A great grandson of this Thomas Wheeler, Dr. Joseph Wheeler, who later was of Ipswich and Salem, Mass., would have been a fifteen year old at Concord in 1695/6 perhaps an apprentice to Concord's Dr. Jonathan Prescott (two of whose wives were Wheelers). Consequently it was no surprise to see that Sanuel was indeed related to one Thomas Wheeler. We have thus looked into the possibility that it was this Thomas Wheeler who married at London, St. Dunstan in the East, 21 December 1585, Sarah Saltonstall (The Registers of St. Dunstan in the East, London 1558-1654, ed. A. W. Hughes Clarke, F.S.A, v. 69 of the Pubs. of the Harlein Soc. [London, 1939], 103), daughter of Richard and Susanna (Poyntz) Saltonstall (Register, 48[Oct. 1894]:502), baptized at London, St. Andrew Undershaft, 7 August 1559 (IGI; Ancestry and Descendants of Sir Richard Saltonstall ... [Riverside Press, 1897], 12 calls Sarah's husband, "Thomas Wheeler or Whaler, Gent. of London", but provides no further information on them). Sarah died after 1597, when her father made his will, "To Sara Saltonstall my daughter, now the wife of Thomas Wheeler, four hundred pounds." (Register, 48[1894]:502). The 1612 will of Sarah's mother left a number of her children unmentioned, as was Sarah (ibid.).

At the baptism of his daughter Elizabeth in 1602, Thomas was, "of Warley" or Wharley End. By 1615, he was "of Borneend" and his eldest son Thomas became, "of Warley" (PR, v. 27, 1, 2).

In the survey of 1623, as Thomas Wheeler, Senior, he had over 29 acres, seven and one quarter being the "Scite of his house with the Ley Close adjoyning;" two and a half acres of "Grove Close;" over four and three quarters of, "The Brache"; and fourteen and a quarter acres, "Tadd Croft and Tyn Meade". In addition, Thomas Wheeler held land from the Manor of Redlands, a four and three quarter acres of pasture.

Thomas Wheeler, senior, yeoman of Cranfield, made his will, 7 December 1627, and it was proved, 24 February 1634/5:

"In the name of God amen the seventh day of december in the yeare of our lord god one thousand Sixe hundred Twenty and Seaven I Thomas Wheler sen of Cranfeild in the county of Bedf, yeoman weake in bodie but of good and pfecte remembrance Gods holie name be praised, doe make & ordayne this my last will & testament in maner & forme followinge, That is to say ffirst I give and bequeath my soule unto allmightie god my Creator hoping assuredly through the merittes of Jesus Christ to be made ptaker of life everlastinge, And my bodie to the Earth whereof it is made. Item I give & bequeath unto Rebeca my wife (for & during the tearme of hir life is she keepe hir self a widow) all that Capitall messuage or tenement with the Apptenances lying & being in the Town end of cranfeeild aforesaid, wch I lately purchased of John Vause Esquire And after the decease of the said Rebecca my wife or day of hir mariage wth anie pson whatsoever I give and bequeath the said Capitall messuage or tenemente with all houses edifices buildings yards gardens pightals groundes comons pfitts & apptenances thereto belonging to Joseph Wheler my sonne and his heirs for ever uppon these Condicons + followinge viz: that he the said Joseph my sonne shall well & truly pay or cause to be payd out of my said ++ messuage & prmises the full sume of Thirtye poundes of lawfull money of England to my executor + or executrix herafter named or to such other pson or psons as my said executor or executrix shall nominate or appoynte of debts where I owe And also pay or cause to be payd out of my said Messuage with the apptenances unto Thomas Wheler my youngest son the full sume of Twenty poundes of lawfull money of ++ England wch sumes of thirty poundes and twenty poundes- are to be payd by the said Joseph within one years after my decease when he cometh to the full age of one & twenty years. And for the better payment of the said some by him the said Joseph I have surrendered to his use Twelve acres of Coppie hold land Provided allwaies & my will & mind absolutly is that is the said Joseph my sonne or his assigns doe not pay the said some of Thirty poundes & twenty poundes in such maner & forme at such dayes & to such pson or psons afore is expressed then the gift & bequest of the said messuage or tenemnt with the apptenances shalbe voyd & of none affect to all intents and purposes whatsoever, And I give & bequeath the said messuage with the apptenances comons & pfitts whatsoever to the said Thomas wheler my youngest sonne & his heires for ever and for default of such issue the remaynder thereof to Efraim wheler my some & his heires for ever anie thing herein to the Contrarie hereof in anie wise notwithstanding, Item I give & bequeath to Thomas wheler of wharly my eldest sonne the some of Twelve pence Item I give to Prisilae Cockes my daughter xiid Item I give to John wheler my sonne twelve pence, Item I give to Elizabeth Bread my daughter xiid, Item I give to Suzana wheler my daughter 12d one ewe lame a table and fframe standing in the plor at Borne end house, It I give to Abiah wheler my daughter one whyte weaning Calfe & Two Table Clotes. It I give to marie wheler my daughter one standing Bedsted & Two Table Cloates, It I give to the said Joseph my sonne one fframe hovell standing in the yard at my messuage at the towne end the old Cart & ould wheeles & a dung Cart, It I give to the said Efraim wheler my sonne one fframe hovell at the ould Borne end, ffower principall postes for a house And all the house Timber under the little hovells in the Close yard at Borne end, and one howed weaninge calfe And my will is that Thomas Tomkins shall lawfully convey and affirm that ffrehold I bought of him to the said Efraim my some & his heirs for ever, It I give to the said Thomas wheler my youngest some one pott one Tegg & flive pounds of lawfull money of England to be payd to him by my executor, or executrix at the age of 24 years, It I give to Allin Bread my sonne in law one Carte Bodie lying behind the stoles in the ould barne & 2 broad Ristes, It I give & bequeath to the said Rebecka my wife all my movable goodes wthin my two dwelling houses at Borne end & the towne end (unbequeathed) and Two heffers the one a Red howed one the other a little Browne one & one Ewe Sheepe, And also my will is that Timothie wheler my sonne shall have half of my messuage Closes + landes & medowes at Borne end aforesaid & half the benifitt & pfitt thereof for Thre yeares next after my decease (for an ease or helpe towards the payment of my debts) All the rest of my goods & Cattelles as well Reales as psonales, unbequeathed, I give & bequeath to the said Timothy my sonne whom I make my full & sole executor of this my last will & testament, And if he the said Timothie refuse to be executor of this my will then I make Rebecka my wife Executrix of this my last will and I doe herby utterly revoke & annull in deed & in law all former wills testaments legaces bequestes by me formerly made, And lastly my will is that the legacy of xx£ shall be payd by the said Joseph to the said Thomas my youngest sonne out of my said messuage with the apptenances when he cometh to the Age of xxi years. In wittnes wherof I the said Thomas wheler the elder have to this my last will & testament set my hand & seale the day & yeare first above written++.

PART B

DESCENT FROM GEORGE WHEELER

OF CONCORD, MASSACHUSETTS

1. (Hon.) George¹ Wheeler was baptized at Cranfield, Beds., 23 March 1605/6 (PR, v. 27, 1, "s Thos Wheler"), and died at Concord, Mass., by 1687 (Wheeler Fam., 17). He married at Cranfield, 8 June 1630, his only wife, Catherine Pin (PR, v. 27, 39, "Cath Pin"; at Cranfield, the name Pin is also spelled Ping and Pyng; at Holcot, Pinge; at Kempston there were Penns, but no Pins; the surname may be a variant of Penn/Paine). She died at Concord, 2 January 1684/5 (VR, 26).

At Cranfield in 1633, this George Wheeler was called, "of Wharley Inn" to distinguish him from George Wheeler, "of East End", who married Mary Studd at Cranfield, 12 May 1628 (PR, v. 27, 38). Both George Wheelers had children baptized in 1633 (PR, v. 27, 5). Consequently, the note by Coddington that George had a second wife (*TAG*, 27:122), no longer applies.

George Wheeler was made freeman in Massachusetts on 2 June 1641 (Register, 3[1849]:189). He was not among the Wheelers petitioning the Massachusetts Bay General Court for land in 1643, but was among those on the October 1654 petition (Wheeler Fam., 1106). Even before 1654, along with John Smedley for Concord, and John Roper and Ralph Houghton for Lancaster, he laid out the road between the two communities (Ruth R. Wheeler, Concord, Climate for Freedom [Concord, 1967, 1970], 85; hereinafter Wheeler, Climate). George Wheeler was one of the overseers for the South Quarter of Concord in 1654 (Lemuel Shattuck, A History of the Town of Concord; Middlesex County, Massachusetts ... [Boston, 1835; reprinted 1985], 35; hereinafter Shattuck, Concord, 35). By 1666, George Wheeler owned 24 lots consisting of 434 acres (ibid., 38), which included his 1660 purchase of one fourth the estate of Grace Bulkeley, widow of Rev. Peter Bulkeley (Wheeler, Climate, 42), including "Nine Acre Corner" (ibid., 220). He was selectman for Concord in 1660 (Tolman, Wheeler, 1).

When Rev. John Jones left Concord for Fairfield, Conn., he put his house up for sale, but was not paid until 1659, its third sale. George Wheeler subsequently owned this house, and sold it to Jonathan Prescott in 1678, probably then building the mansion house (Wheeler, *Climate*, 22, n.), which he left to his sons Thomas and John.

The 28 January 1684/5 will of George Wheeler, Senior, of Concord, was proved 2 June 1687. He named sons Thomas and John; children of deceased son William; daughters Elizabeth Fletcher, Sarah Dudley, Ruth Hartwell, and Hannah Fletcher, children of his daughter Fox. Witnesses were Samuel Merriam, Jonathan Hubbard, and John Scotchford. (Wheeler Fam., 17; also see G. A. Taylor, "Stray Wills at Suffolk County [Mass.] Probate Registry", TAG, 14[Oct. 1937]131.)

John Wheeler served in the Narraganset Expedition of 1675, by virtue of which his son Ebenezer was granted land in 1735 (*Register*, 16[1862]:146).

On 21 October 1713 [also entered as twelfth year of the reign of Queen Anne, who came to the throne in 1702], an agreement was made among the heirs of John Wheeler to settle the estate. The widow, Sarah Wheeler made her mark. Children signing were Samuel Wheeler, Edward Wheeller [sic], and Ebenezer Wheeler. On behalf of their wives, the following signed: Wm Woodbury, John Meriam, Samuel Prescott, Jonas Prescott, John Meriam Junr. and Timothy Wheeler. Witnesses were John Heywood and Joseph Dakin. (Agreement, Middx. Probate No. 24290.)

She married second at Concord, 21 April 1720, Nathaniel Stow (VR, 98), son of Nathaniel and Martha (Bignell) Stow, born at Concord, 18 September 1663 (VR, 11), and died there 12 November 1724, in his 62nd year (VR, 110); his children were by his first wife, Ruth Merriam. For the continuation of Lydia's line, see No. 3, Timothy Wheeler in Part C, "Descent From Thomas Wheeler, Senior, of Concord, Massachusetts, and Fairfield, Connecticut.

PART C

DESCENT FROM THOMAS WHEELER, SENIOR

OF CONCORD, MASSACHUSETTS, AND FAIRFIELD, CONNECTICUT

1. THOMAS¹ WHEELER, the eldest son of Thomas Wheeler of Bourne End, Cranfield, Beds. (TAG, 14:1), was born say 1588, and died at Fairfield, Conn., in 1654 (Jacobus, Fairfield, v. 1, 662). He married at Cranfield, 5 May 1613, Ann Halsey (PR, v. 27, 37), daughter of Robert and Ellen (Alley alias Cooke) Halsey alias Chambers, baptized at Flamstead, Herts., 30 May 1591 (PR), and died at Fairfield, Conn., in 1659 (Jacobus, Fairfield, v. 1, 662).

Thomas Wheeler of Wharley End, Cranfield, Beds., removed to New England, probably by the summer of 1638. On the lists of arrears in the payment of King Charles I "ship money tax" for the Hundred of Redbournestoke, under Cranfield, Thomas Wheeler was in arrears on the list dated 14 July 1638, by an even one pound, with the notation, "Gon out of the Country" (List TW 869 at Beds. Rec. Off.; also see John Insley Coddington, "The Wheelers of Bedfordshire and New England", TAG, 28[1952]:257; also see Bedfordshire Historical Record Society, Civil War And Ship Money Papers [1936], v. 18, 73). On a subsequent update, but undated list, Thomas Wheeler was in arrears by £1, 5s and this list was annotated next to his name, "Gone into New England" (List TW 857, p. 7, at Beds. Rec. Off.; also see Jacobus, TAG, 14[1937]:4.

A Thomas Wheeler was made freeman in New England on 17 April 1637 (Register, 3[1849]:95). One source connects the freeman of 17 April 1637 to Thomas Wheeler of Concord and Fairfield, but then also connects that same date to Thomas Wheeler, a tailor of Boston (Wheeler Fam., 200, 485). Of course, that date pertains to the tailor, not to Thomas Wheeler, Senior, who was still at Cranfield.

An early record of Thomas Wheeler, Senior, in New England, was a petition for land at Concord, dated 7 September 1643. It stated that the petitioners, Thomas Wheeler, Timothy Wheeler, Ephraim Wheeler, Thomas Wheeler, Jr., Roger Draper, and Richard Lettin, came into the country about four years earlier (*Wheeler Fam.*, 1105). Thomas Wheeler, Senior, departed shortly thereafter for Fairfield, Conn., where it was recorded that he erected a stone house with a flat plank roof. On the roof he placed two cannon; one pointed at the mouth of Black Rock Harbor, and the other at an Indian fort, with a

population of nearly two hundred, at the head of the harbor (Schenck, Fairfield, v. 1, 2, 42).

By January 1649, Thomas Wheeler, Senior, was granted a home lot of two and one half acres at the Pequonnock settlement, next to his brothers Ephraim Wheeler and Thomas Wheeler, Junior (*ibid.*, 66).

Thomas Wheeler, Senior, of Fairfield made his will 5 May 1654, proved 23 August 1654, naming wife Ann; elder son Thomas at Concord, to receive property there; son John, lands at Fairfield; daughter Sarah, wife of Thomas Sherwood, and their son Thomas; grandchildren Mary, James, Thomas, and John Bennett; overseers were brother Thomas Wheeler, Lieutenant, Robert Lockwood, and Andrew Ward, all of Fairfield; Ephraim Wheeler was named an appraiser (Jacobus, *Fairfield*, v. 1, 662).

Ann Wheeler made her will 21 August 1659, naming elder son Thomas, his wife and children; Sarah and Hannah Bennett, children of her daughter Hannah; grandchild Sarah Sherwood; Annis Sherwood, wife of her son-in-law; she left her best hat to Rebecca Turney, and a petticoat to Ann Squire; inventory was 20 October 1659 (*ibid.*, v. 1, 663; the end of the will was not legible).

(Hon.) Thomas Wheeler of Milford, Conn., and his brother William Wheeler of Stratford, Conn., sometimes shown as children of this couple (Wheeler Fam., 200), are not their children. The error came about after a transcriber at Cranfield misread the name Ephraim as William in the baptism entry of 16 March 1618[/19]. Jacobus pointed out the error, as is evident from the will abstract above that the elder son Thomas was living at Concord, Mass. (Jacobus, Fairfield, v. 1, 662). Jacobus further showed that Thomas Wheeler, Senior, of Fairfield; Timothy Wheeler, of Concord; Ephraim Wheeler of Fairfield; and [Capt.] Thomas Wheeler, Jr., were all sons of Thomas Wheeler, the elder, of Bourne End, Cranfield (TAG, 14:1). The will of Timothy Wheeler named his nephew, Sgt. Thomas Wheeler, and also children of his brother [Capt.] Thomas Wheeler (Wheeler Fam., 134). It is thus certain that Thomas Wheeler of Milford, and his brother, William Wheeler of Stratford are of a different family group (see also George Dudley Seymour, "A Seventeenth Century Letter", Register, 62[Jan. 1908]:82, which indicates that Henry Dell of Wigginton, Herts., married a sister of Thomas and William; the IGI shows that Mary Wheeler married Henry Dell at Wigginton, 15 October 1639).

He married second at Concord, 23 July 1677, SARAH (BEERS) STEARNS (VR, 20), daughter of Capt. Richard and Elizabeth (----) Beers, born at Watertown, Mass., 5 October 1639 (VR, v. 1, 6), died at Concord, 21 January 1723/4 (VR, 110) and widow of Isaac Stearns of Lexington (Hudson, *Lexington*, v. 2, 663).

He was probably the Thomas Wheeler made freeman on 7 October 1641 (Register, 3[1849]:189), although there were too many of the name to be certain. He was plain Thomas Wheeler in the 1649 birth record of his first daughter. When a group of his children were recorded in 1658 though, about the time George Wheeler's son Thomas married, he was called Thomas Wheeler, Senior. In 1662, Thomas Wheeler, Senior, was appointed one of two sergeants in the company of foot, under his uncle, Capt. Timothy Wheeler (Shattuck, Concord, 46), and by 1664, he was being referred to as Sergeant on the birth records of his children.

He married first at Concord, 25 June 1719, ABIGAIL MUNROE (VR, 98), daughter of William and Mary (Cutler) Munroe, born at Lexington, Mass., 28 June 1701 (Hudson, Lexington, v. 2, 450), and she died in 1743. He married second at Concord, 31 May 1744, MEHITABLE WHITTEMORE (VR, 161), daughter of Benjamin and Esther (Brooks) Whittemore, born at Concord, 9 April 1705 (VR, 63), and died there, 2 March 1772 (VR, 223).

The record calls him Captain Timothy Wheeler [which distinguished him from Timothy⁴ Wheeler, Junior (*Ebenezer*³, *John*², *George*¹), who was born in 1716/7; Timothy Wheeler, Jr., was one of the three Concord selectmen to sign the resolution on the taxation of tea (Shattuck, *Concord*, 78, 79)]. In May 1755, Timothy Wheeler was a 2d lieutenant in Captain Osgood's company, during the expedition to Nova Scotia (*ibid.*, 72).

In February 1775, Concord exercised great caution to see that the articles of association were observed,

"Several meetings were held; and such measures, as the state of the times required, adopted. Capt. Timothy Wheeler, Mr. Andrew Conant, Mr. Samuel Whitney, Capt. John Green, Mr. Josiah Merriam, Mr. Ephraim Wood, jr., Mr. William Parkman, and Capt. Thomas Davis, were added to the committee of inspection, and directed to return the names of those who declined signing the articles of association. Such were to be treated with neglect and detestation." (*ibid.*, 94).

Among the stores furnished by the committee of supplies, 66 barrels of flour were stored by Capt. Timothy Wheeler (*ibid.*, 98), who also furnished oatmeal (*ibid.*, 99). Some of the stores in the center of town were broken open by the British troops who entered the town. The liberty-pole on the hill was cut down and nearly five hundred pounds of lead were disposed of in wells and in the mill pond.

"The shrewd and successful address of Captain Timothy Wheeler on this occasion deserves notice. He had the charge of a large quantity of provincial flour, which together with some casks of his own, was stored in his barn. A British officer, demanding entrance, he readily took his key and gave him admission. The officer expressed pleasure at the discovery; but Captain Wheeler with much affected simplicity, said to him, putting his hand on a barrel; "This is my flour. I am a miller, Sir. Yonder stands my mill. I get my living by it. In the winter I grind a great deal of grain, and get it ready for market in the spring. This,' pointing to the barrel, 'is the flour of corn; this is the flour of rye; this,' putting his hand on his own casks, 'is my flour; this is my wheat' this is my rye; this is mine.' 'Well,' said the officer, 'we do not injure private property'; and withdrew leaving this important depository untouched." (ibid., 107-108, from Holmes Annals, v. 2, 326).

He married first at New Ipswich, N.H., 25 December 1788, ELIZABETH Cook (Chandler, New Ipswich, 689), born October 1771, and died after a fire consumed her house (ibid.) 27 March 1807 (Family Record of Gordon Boyce Wheeler; hereinafter FR). He married second at Waitsfield, Vt., say 1810, Lucy Palmer, daughter of Jonathan and Betsey (Quimby) Palmer (Matt Bushnell Jones, History of the Town of Waitsfield, Vermont 1782-1908, With Family Genealogies, 508; hereinafter Jones, Waitsfield; but Jones incorrectly ascribes Lucy as the wife of William Wheeler, son of her husband), and she married second at Waitsfield, 22 January 1836, Elijah Grandy of Waitsfield (VR, 125).

On 29 December 1795, William Wheeler, being of Windsor, Windsor Co., Vt., bought for £85 lawful money, Lot 81, a 150 acre parcel at Waitsfield, Chittenden Co., Vt., from Stephen Maine, of Hartland, Windsor Co., Vt. On that same day he gave a mortgage to Stephen Maine in the amount of \$283.33 & 1/3¢ plus lawful interest on three notes, \$100.00, payable on 1 March, with interest after that time. Another of the same, payable 1 March 1797, with interest until paid; and the other for \$83.33 & 1/3¢ with interest until paid (Waitsfield, Vt., Land Records, 64; recorded 20 Oct. 1796).

He lived the greater part of his life in Vermont, for a while at Windsor, and then removing to Waitsfield, his home for a considerable time. Tradition and some fire damaged furniture which was brought back to New Ipswich by a son, indicates that Elizabeth lost her life, along with a babe in arms, trying to retrieve some prized possession while fire ravaged her home (Chandler, *New Ipswich*, 689).

On 28 April 1812, William Wheeler, Junior, of Waitsfield, Jefferson Co., Vt., bought of Benjamin Richardson, for \$260.00, the west half of Lot Eleven in the fifth range of lots, Town of Fayston, Vt., which lot was drawn to the first division of Jeremiah Rust. On the same day, William Wheeler mortgaged the property to Benjamin Richardson for five notes

dated 28 April 1812, one for \$100.00 of grain, due 10 January 1813; one for \$40.00 in wheat, due 1 January 1814; one for \$40.00 of wheat, due 1 January 1815; one for \$40.00 in grain, due 1 January 1816; and the last note, for \$40.00 in grain, due 1 January 1817, all on interest until paid (Fayston, Vt., Land Records, 248; recorded 28 April 1812).

William Wheeler was a volunteer during the War of 1812 (Chandler, New Ipswich, 693). With others from Waitsfield, he marched to Burlington, to help repel the British invasion of Plattsburgh in September 1814; however, the contingent, under command of Capt. Matthias Jones, arrived too late for transportation across Lake Champlain (Jones, Waitsfield, 78). Sophia received a pension for her husband's service (War of 1812, Pension No. 28558).






1. Buckinghamshire and Bedfordshire Parishes About Cranfield

3. Bourne End, Cranfield, Bedfordshire




4. Saint Peter and Saint Paul's Church, Cranfield, Beds.

The Parish Church on Court Street in Cranfield, has its origins in the 12th century, with portions added through the 15th century. During the 1860's, it was restored by T. C. Hines.


The Wheelers attended this church before coming to America in 1638 and 1639. One of the family, who remained at Cranfield, Rev. William Wheeler, was the rector here before leaving it to found the Cranfield Baptist Church in 1662. Rev. Wheeler was a friend of John Bunyan, who most likely preached at Cranfield.

General George Washington's niece, Lydia Hallworth, is buried here in the churchyard; she died 4 November 1863, aged 83.

In 1938, William White of Philadelphia, to remember his ancestors from Cranfield, replaced the original baptismal font in the church.

George Wheeler bequeathed his "mansion dwelling house" to his sons Thomas and John in his 1687 will. That would refer to a different house than the one depicted above, however. George Wheeler sold this one to Jonathan Prescott before 1680.

Jonathan Prescott's third wife, Lieut. Joseph¹ Wheeler's daughter, Rebecca (Wheeler) (Bulkeley) Prescott, lived here. After she died in 1717/8, Jonathan Prescott married his fourth wife, daughter of Capt. Thomas¹ Wheeler, Ruth (Wheeler) (Jones) (Browne) Prescott.

Originally this house was built for the Rev. John Jones, who removed to Fairfield, Conn., in 1644.



Henry David Thoreau was born in this house which originally belonged to Sgt. Thomas² Wheeler's son John. It was the home of Thoreau's mother following her mother's second marriage to Capt. Jonas Minot. Jonas Minot was a grandson of Capt. Timothy¹ Wheeler's daughter Rebecca, and also of George¹ Wheeler's granddaughter Thankful.

Thus, while Henry David Thoreau was not descended from the Wheeler's, his mother's stepfather descended from two of Concord's earliest Wheeler families, and grew up in the house of a third.

8. Home of Timothy³ Wheeler, Virginia Road, Concord, Mass.


Built as a wedding present by Timothy's father, Sgt. Thomas² Wheeler, this house stands at 477 Virginia Road. The house, Pine Hill behind it, the barn, and Elm Brook, have changed little since Timothy and his wife Lydia, granddaughter of George¹ Wheeler, were the first inhabitants, even surviving a fire that destroyed the east wing of the house. Over the years it has been the home of a number of Concord families, including the Merriams. Known as Pine Hill Farm for a time, it is more recently Elm Brook Farm.

The 1692 deed described the location as being across the street from Sgt. Thomas Wheeler's dwelling house, which was situated to the west.
